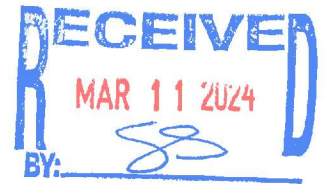


PETITION TO FLAGSTAFF CITY COUNCIL
