The City of Flagstaff Commission on Inclusion and Adaptive Living (CIAL) has been established with the duty to advise the Flagstaff City Council on issues affecting individuals with disabilities in our community. With our duty in mind, we are submitting this letter to provide a voice of support for those members of our community whom we represent.

It has come to our attention that there is a severe lack of wheelchair accessible vehicles (WAV) in Flagstaff, especially among taxi providers, Ubers, and Lyfts. Based on a 2023 survey conducted with social service agencies in Flagstaff, 73% of those responding reported unreliable on-demand WAV access in Flagstaff and 42% reported individuals in need of wheelchair accessible transportation often or all the time.

Due to this severe need that is currently not being met, the City of Flagstaff Commission on Inclusion and Adaptive Living is eager to see more Wheelchair Accessible Vehicles come to Flagstaff so as to provide on demand transportation for all. The Commission is supporting and assisting the Wheelchair Accessible Vehicle Subcommittee (of the Coordinated Mobility Council) in assisting a local taxi company to find donations and resources to purchase a WAV. The taxi company identified understands the need in Flagstaff and has great interest in providing wheelchair accessible service. However, there are financial barriers to purchasing a WAV.

This company is new to Flagstaff and is a small, family owned business. The WAV subcommittee is seeking to explore funding options such as donations for interested taxi or transit network companies willing to invest in the future of equity of mobility services for all in Flagstaff. We hope this issue strikes your enthusiastic support and resource sharing. The WAV Subcommittee and the City of Flagstaff CIAL look forward to hearing back from you.

Letter to Council

To the City of Flagstaff Mayor and Members of the City Council:

The Commission on Inclusion and Adaptive Living (CIAL) has been established with the duty to advise the City Council on issues affecting individuals with disabilities in our community. With our duty in mind, we are submitting this letter to you to provide a voice of support for those members of our community whom we represent.

Since early in the spring of 2023, the CIAL has been discussing how sidewalks in our community are obstructed and encroached upon, often denying accessibility to members of our community with mobility challenges. At times, these obstructions and encroachments completely prevent individuals with mobility challenges from accessing businesses, schools, government buildings, and even homes. We on the CIAL consider this to be very serious problem for and within the City of Flagstaff. Sidewalks provide space for use by pedestrians that is safe, comfortable, and accessible to ALL. Infringement on this space, including obstructions and encroachment on sidewalks, is damaging and dangerous to our community.

With this in mind, last October, members of the CIAL presented to the City Council a PowerPoint presentation that identified multiple concerns related to our sidewalks. Those concerns included bulk trash and trash cans impeding sidewalk flow, sidewalks in need of repair, vehicles being parked on sidewalks, and lack of snow removal.

We are able to report that since October we have seen some improvement in some of these areas. Following discussion with the city's Solid Waste division, city trash truck drivers have become much better at dropping trash cans at the curb rather than on the sidewalk following pickup. We have also seen the CIAL's liaisons on Sidewalk and Parking Compliance work with the city's Code Compliance staff to encourage compliance with city ordinances. And, we are thrilled to see the city's Sustainability staff initiate the Snow Heroes program which will help with sidewalk clearance of snow for those residents with physically challenging needs.

However, our overall observation of our city's problem with sidewalk obstruction and encroachment shows that unfortunately, we have not seen as much improvement as we have hoped for. This past winter we observed many of our city's sidewalks go uncleared repeatedly and we know of an elderly gentleman of our community who slipped on an uncleared sidewalk, was severely injured, and subsequently passed away from those injuries. We also continue to see many, many residents place trash cans and bulk trash on the sidewalk and all over the city, residents continue to park cars on the sidewalk. Often, these violations of city ordinance repeatedly occur at the same residences and while these habitual violators have been reported to city staff multiple times, no change in behavior is noted.

In the interest of improving the sidewalk situation, one member of the CIAL, as a private citizen, posted concerns about sidewalk obstruction and encroachment on social media with an appeal to our community for neighborly assistance. Multiple comments were replied, almost all complaining of a lack of enforcement of city ordinances by city staff. It is extremely

discouraging to learn that many members of our community feel that the city does not take enforcement of the clear sidewalks ordinances seriously.

When CIAL members presented to the City Council in October, one Council member called for “education, education, and then enforcement.” At this time, the CIAL feels that education has been occurring but due to lack of clear sidewalk improvement, increased enforcement of our city ordinances is now called for. Residents who continue to block sidewalks with trash cans, bulk trash, parked cars, and uncleared snow and ice need to be cited. It seems that without increased enforcement and citation, these violations will just continue to occur in the mass numbers that are happening now. And for the disability community of Flagstaff, this is simply not acceptable as accessibility and safety are being threatened.

So again, at this time the CIAL is strongly encouraging the City Council to meet with city staff to encourage increased enforcement (through citation) of city ordinances related to ensuring clear, accessible sidewalks for all our community’s citizens. We feel this is a necessary step in providing a safe environment for all.

We appreciate your time in listening to our concerns and thank you in advance for your time and attention in addressing them. We look forward to your response.
