CIAL Informal Working Group on Therapeutic Recreation

Summary of Meetings:

The three meetings focused on information gathering related to therapeutic recreation (TR) services in Flagstaff. The group included representatives from the City of Flagstaff PROSE, Coconino County, other commission chairs, nonprofit organizations, and Northern Arizona University (NAU).

The discussions covered the history of TR services in Flagstaff, existing PROSE facilities and programs that could be leveraged, partnership opportunities with organizations like HCAS (High Country Adaptive Sports), potential funding sources, professional development needs for PROSE staff, and the long-term goal of reopening the previously dedicated TR building (McPherson House).

Recommendations:

Based on the priority items discussed, the following recommendations can be made to the Commission on Inclusion and Adaptive Living for further discussion and action:

1. Short-term:

- Provide a CIAL table with information and to collect insights from the disabled community at PROSE events throughout the summer – particularly the Concerts in the Park series since it rotates locations.
- Provide training and professional development for PROSE staff on inclusive programming, sensory-friendly events, and accommodating individuals with disabilities. Partner with organizations like Kaibab Behavioral Services, NAU, and welcomed here for training.
- Adapt existing PROSE programs and facilities (e.g., Aquaplex, Jay Lively, Montoya Center, Youth Center) to be more inclusive and accessible.

2. Medium-term:

- Increase funding for TR services through partnerships with organizations that can apply for grants such as AZ Community Foundation, United Way, and exploring Arizona waiver programs.
- Facilitate professional development opportunities for PROSE staff to obtain the qualified provider credential of Certified Therapeutic Recreation Specialist (CTRS) through partnerships with NAU's Parks and Recreation Management – Graduate Certificate in Recreational Therapy program.
- Expand TR programming by leveraging existing and new partnerships with organizations like HCAS, Ability360, and Arizona Disabled Sports.

3. Long-term:

- Allocate resources to update and reopen the previously dedicated TR building (McPherson House) to provide a centralized hub for TR services.
- Explore synergistic relationships with the planned Indigenous Center at Thorpe Park for shared use of spaces.
- Consider creating a grant-writing position within PROSE to better pursue funding opportunities for TR services.

Additionally, the commission could recommend conducting a community survey (as suggested by HCAS) to better understand the needs and preferences of individuals with disabilities and their families regarding TR services in Flagstaff. This could be a joint survey with HCAS (currently designing one) or expanded questions on the PROSE survey about facilities (to be designed).
