Dear members of City and County Boards and Commissions,

Thank you all for your ongoing interest and feedback as we develop the Flagstaff Regional Plan 2045 (not to be confused with the County Comprehensive Plan, which is also being updated). Several liaisons and members have reached out as we are concluding the Scenario Choosing process and asking how they can continue to be involved.

The Regional Plan Committee is starting its review draft chapter in February according to the [schedule published on the project website](#). Attached you will find an initial list of RPC meetings and the Boards and Commissions we anticipate sending a packet and direct invitation to.

We encourage you as a commission to send up to 2 representatives to these meetings and to review the draft chapters with us. Because we have a City and County appointed committee of 25 members, spoken public participation time is limited to 20 minutes per meeting but an unlimited number of written comments may be sent to RegionalPlanCommittee@flagstaffaz.gov either before or up to a week after the Committee meeting.

Because the goal is to move this process forward quickly and to produce a draft plan by the end of the summer, project staff will not be able to attend to individual board and commission meetings to give you an update. The Committee welcomes your attendance and written comments and encourages you to use the Committee meetings as the opportunity to be engaged in the process. There will also be opportunities to attend public workshops and meetings as they are scheduled.

Staff will schedule to attend one of your meetings to review the complete draft plan and discuss it with you during the 60-day public review. Please leave room in your fall meeting schedules for these presentations.
