5. Open Call to the Public

Chair Thomas read the Open Call to the Public statement. No public comments were received.

6. Business Items

A. Regional Plan Review and Recommendations

Robert Wallace began the review of the Regional Land Use Plan draft by introducing commissioners to City of Flagstaff, Neighborhood Planning Manager, Sarah Dechter who is the project lead and would be providing commissioners with feedback and comments on their suggestions for modifications to the Regional Land Use Plan. Sarah stressed the importance of

sending in comments on the draft Regional Land Use Plan in a timely manner and to the correct email (RegionalPlan45Comments@flagstaffaz.gov). She also noted that with this draft of the Regional Land Use Plan, they have been working with over 2000 public comments and over 800 internal staff comments.

Chair Thomas began the Commission's presentation of their comments on the Regional Plan. The Commission went through each question and comment that they had identified, condensed to 14 points for revision consideration. Revision topics are listed below.

- 1. Balancing "core priorities" directive so that Open Space is not de-prioritized in project decisions.
- 2. Recognizing the importance of the Flagstaff Urban Trail System in the policy section, not just transportation, and require it to be thoughtfully located through new developments.
- 3. Make 10-minute walking, access to parks or open spaces, a policy target.
- 4. Clarification of Map 3-1 and associated text to avoid the impression that only one geographical type is considered for open space.
- 5. Brown box text, Chapter 3, p. 3-12: revision of text about "City-owned parcels with open space dedications."
- 6. Avoid limiting the terms of conservation to "significant" or "uncommon" resources only.
- 7. Re-framing Policy OS.2 so that it does not read as "open space only where development can't go."
- 8. Update to the Policy Map designations and trail continuity in Chapter 4.
- 9. Update the viewshed responsibility language in Chapter 7.
- 10. Request that Ponderosa Pine tree stands be mapped and managed.
- 11. State that the "integration" of Open Space is as important as "access" in Chapter 8.
- 12. Strengthen Chapter 8's action items and timelines.
- 13. Recommendation on implementation tools such as incentives, density bonuses, partnerships and expedited reviews to encourage developers to incorporate the 10-minute walking access standard.
- 14. Revision of glossary terms: Parks, Active, Passive Recreation.

Commissioners and Sarah Dechter had an extensive back-and-forth conversation on each of the topics before concluding their discussion of the Regional Land Use Plan. Sarah told Commissioners that no decisions would be made at the September 10th public hearing with the City Planning and Zoning Commission. Robert asked if the Commission could present at any of the upcoming meetings. Sarah replied that the Commission should submit their comments in writing and then present a brief summary at the meeting on September 10th.

It was decided that the Commission would need additional time to brainstorm and revise their Regional Plan comments document. Commissioner's plan to update the document to reflect an abbreviated set of comments as some were already covered by Sarah at today's meeting. To vote upon their updated Regional Plans comments, the Commission decided to hold a special meeting on September 8th at 4 PM -- virtual only.

5. **Business Items**

A. Regional Plan Review and Recommendations

Chair Thomas shared a brief overview on what the meeting would be covering, including a final review of the Commission's recommendations for the Regional Plan draft and selecting a Commissioner who will present at the upcoming Planning and Zoning Commission meetings. Robert Wallace shared that he had worked with both Chair Thomas and Co-Chair Fox on revisions the previous week, as well as meeting with Sara Dechter who provided additional comments on the Commission's recommendations. To begin the final discussion and review of the Commission's recommendations, Robert shared on the Teams meeting a copy of the draft letter from Commissioners that included the list of recommendations they came up with at the previous meeting on August 25th.

Additional comments made on the list of recommendations:

- 1. Edit "non-negotiable" statement in Chapter 3, p. 3-1.
 - Commissioners discussed alternative word choices such as 'declared', 'balanced', 'primary', or 'important'.
 - Keeping this recommendation with additional edits.
- 2. Recognizing the importance of the Flagstaff Urban Trail System (FUTS) in the policy section, not just Transportation. Revision in Chapter 3, p. 3-9.
 - Commissioners discussed prioritizing the accessibility and connectivity of FUTS. Including a section on it outside of Transportation would help recognize the importance of FUTS, and it's integration with other trails.
 - Keeping this recommendation with additional edits.
- 3. Make the 1/4 mile to 1/3 mile Walking Access Standard a policy target. Chapter 3, p. 3-10
 - Amy Hagin provided input from a parks and recreation perspective that keeping reference to the 10-Minute Walking Access Standard would be more beneficial as that is the national benchmark for equitable access to open spaces and parks.
 - Keeping this recommendation with reference to the 10-Minute Walking Distance.
- 4. Clarification to Map 3-1 and related text. Chapter 3, p. 3-11, Map 3-1.
 - Keeping this recommendation.
- 5. Revision to Policy PROSE.4. Chapter 3, p. 3-12.
 - Commissioners discussed changing the wording surrounding Interagency coordination.
- 6. Reframe Policy OS.2 to not read as "open space only where development can't go." Chapter 3, p. 3-14.
 - Keeping this recommendation.
- 7. Fix the Policy Map designation to acknowledge trail continuity as a top priority connection. Chapter 4, p. 4-9 and 4-10. Map 4-1 and 4-2.
 - Commissioners discussed the impacts that different zoning types and private land ownership have in relation to Open Space access.
 - Keeping this recommendation and additional edits.
- 8. Remove the reference to private parcels over 400 acres. Chapter 4, p. 4-37.
 - Keeping this recommendation
- 9. Reframe the map disclaimer to ensure trails are included in the design. Chapter 4, p. 4-37 and 4-38.
 - Keeping this recommendation with additional edits to the disclaimer statement.
- 10. Add missing existing trail right-of-way access to map 4-6. Chapter 4.
 - Keeping this recommendation
- 11. Add trail access points and trailheads to map 4-5. Chapter 4.
 - Keeping this recommendation
- 12. Update the bikeway policy plan map. Chapter 4, p. 4-39, Map 4-7.
 - Commissioners commented that any new roads planned in the future should include bikeways.
 - Keeping this recommendation
- 13. Recognize the importance of FUTS and other trails in Chapter 4, and require it to be added throughout new developments.
 - Keeping this recommendation.
- 14. Making "integration" as important as "access" in neighborhood policy.
 - A recommendation was made by Robert to update the proposed sentence change.
 - Keeping this recommendation with the addition of Robert's update.
- 15. Strengthen Chapter 8 action items and timelines.
 - Keeping this recommendation.
- 16. Map stands of ponderosa pine.
 - Commissioners discussed various viewpoints on the need to map ponderosa pine and the goal of having a community tree inventory.
 - Commissioners remained in favor of keeping this item as ponderosa pine is one of Flagstaff's largest natural resources.
- 17. Recommendation on Implementation Tools.
 - Keeping this recommendation, but combining it with #15 to strengthen Chapter 8 action items and timelines.

Chair Parsons read the public comment statement. No comments were received.

6. **Business Items**

A. Flagstaff Regional Land Use Plan 2045 Update

Robert Wallace, PROSE Open Space Supervisor, shared with both commissions an update on the Open Spaces Commission decision to review and submit recommendations on the draft Regional Plan. He said that the Open Spaces Commission had also nominated various commission members to present at upcoming Planning and Zoning Commission meetings and City Council. The Open Spaces Commission's recommendations on the draft plan have been submitted and will be discussed at the Planning and Zoning Public Hearing on September 24, 2025. Chair Thomas, who presented at the Planning and Zoning Commission meeting on September 10th, shared the commission's three main points:

- 1. A need to ensure that open space is integrated into the plan in a way that better aligns with the core priorities of housing and climate and provides a better balance.
- 2. The need to guide development so it helps deliver the things that the community values, such as parks, trails and access points, and open spaces. Specifically, the Open Spaces Commission recommended map updates that pertain to open space needs for the community.
- 3. A recommendation to correct the Future Growth illustration maps to prevent the loss of a top priority trail corridor between the Rio de Flag Water Reclamation Plan and Forest Service land. Currently, the Future Growth illustration map proposes a Surburban Center within the trail corridor, including a medium-to-high density of people, residences, jobs and activities. Development goals for this zoning type may not support the long-standing trail corridor priority.

The discussion items that the Planning and Zoning Commission votes on and approves will become part of their recommendations of approval for City Council's consideration at the October 9th City Council meeting.

No further questions or comments from Commissioners.

B. PROSE Capital Improvement Project Overview

Amy Hagin shared on the presentation screen in the meeting room, a table with all major projects from this fiscal year (FY26)—including projects from upcoming fiscal years (BBB fund and capital-funded projects). The table combined various PROSE projects that applied to both Open Spaces and Parks and Recreation Commissions.

- Parks & Recreation: Bushmaster Park sports court project has a projected completion time of November 2025.
- Parks & Recreation: Hal Jensen Recreation Center air conditioning: Design for adding AC
 throughout the entire building has been done. The AC will first be installed in the gymnasium
 with plans for future AC installation happening when additional funds are available for more
 units.
- Parks & Recreation: Highland Mesa, a new park near the Boulder Pointe neighborhood, has
 funding for development with the hope to be completed by FY27. The project is currently in the
 concept design stage.
- Parks & Recreation: Heritage Square restroom remodel. The two restrooms have been seeing
 ongoing misuse. With this upcoming remodel project, PROSE staff hope to change the
 restroom layout, and as a result, also see changes in the type of restroom use behaviors. Staff
 have been working with the Downtown Business Alliance and other entities to make the
 restrooms a better space for all users.
- Parks & Recreation: Annual playground equipment replacement. An ongoing project that tackles replacing outdated playground equipment that is in need of replacement.
- Parks & Recreation: Cheshire Park expansion project. The future home of a running track and
 multipurpose field. There is a need within the community for a public running track as there is
 no other public running track available. PROSE staff are looking into a possible grant to
 leverage this project that would include a permanent restroom. Commissioners voiced
 concerns regarding the impact that lighting for the track may have on the community's dark sky
 designation and if the turf for the track could cause unwanted heat impacts to the
 neighborhood and nearby wetlands. Amy replied to each, justifying that the lighting would

remain dark-sky compliant, and that they have weighed various options for turf versus non-turf and while that is not solidified yet, they are leaning towards artificial turf.

- Parks & Recreation: Ponderosa Park reconstruction project. Impacted by the flooding from the Museum Fire scar, Ponderosa Park will undergo reconstruction in FY26/27.
- Open Spaces: McMillan Mesa Trails. Robert Wallace shared that this project would include trail repair and upkeep.
- Parks & Recreation: Continental Park future expansion project. Amy shared that the park is a
 heavily used location with the potential to expand to upwards of 86 acres. The City owns a
 narrow strip of land north of the park, extending to I-40. PROSE has projected the project to
 begin with 3 million dollars and would cover at least two fiscal years, with most of that money
 going to the initial design of the additional 86 acres and possible easements they would need
 to acquire.
- Open Spaces: Trail repairs, FUTS connections, and land acquisitions.
 - Picture Canyon Trail Connection. This project will work to secure needed easements to permit the construction of a trail to the Picture Canyon Preserve from Route 66. This will improve access and make progress towards providing 10-minute walking access to open space for residents. The project would take place in FY2027-2028.
 - Land Acquisition. This project would provide approximately \$800,000 in FY 28 to help acquire property that is integral to the Open Space System, such as Regional Preserves, Connectors, and Complementary lands, to create an integrated network of open space throughout the community to provide equitable access and recreational opportunities.
 - Observatory Mesa Natural Area Plan. This project is projected to stretch across several fiscal years from 2028 through 2035, and will consist of restoration of unauthorized routes, updating signage, creating new trails, and developing basic trailhead amenities. Currently, PROSE staff are working to produce a support trail corridor. Next year, they anticipate applying for a permit with the Coconino National Forest, which would support the project's implementation.
 - McMillan Mesa Property Restoration, FY 29. This project will work to restore property with attention to erosion control, addressing unauthorized trails, providing tree buffer between development and the urban trail system, and mitigating invasive plants.

C. PROSE Master Plan Update

Rebecca Sayers shared that PROSE would begin working on a master plan project within the upcoming year. This master plan would expand upon their current Parks and Recreation plan to include both Open Spaces and Events. This will be a comprehensive plan that will help PROSE better prioritize how they operate in the future by following a guide with set goal points that more accurately serves current PROSE operations. She added that they are working on the formal procurement and hope to be able to begin shortly after the start of 2026. Both commissions should anticipate heavy involvement in this process once a consultant group has been selected.

D. Flagstaff Urban Trail System (FUTS) Maintenance Update

Amy shared a Powerpoint presentation with the Commissions that highlighted various FUTS accomplishments this past summer. Roughly 8.5 miles of existing urban trail sections received varying levels of repair with different types of treatment on asphalt. The presentation referenced various before and after photographs on the slideshow.

E. PROSE Division Collaborations

Amy provided a recap of the 4th of July Drone Show, highlighting the success of that event between both Open Space staff and Parks and Recreation staff coming together to make the event happen that is managed by the Events Section.

Open Space staff shared a collaborative project for invasive weed control that Open Space had been working on and will be wrapping up this Fall, associated with a Department of Forestry and Fire Management grant. They also mentioned a cross-division collaboration between Open Space and Parks staff that included-assisting with illegal campsite cleanup and new signage installations, weed work on varied city property, an arbor day tree plant scheduled to take place at Thorpe Park,

and educational collaborative efforts between Open Space and Recreation

7. City Council Liaison Reports - Councilmember Anthony Garcia and Councilmember David Spence

Open Spaces Councilmember Representative David Spence shared highlights of guided tours of PROSE properties that both commissions manage. He mentioned that on his tour of Continental Park, during the discussion of the park's expansion, he thought that the idea of an outdoor theater (something that is similar to the likes of Red Rock's theater in Colorado) could make a great addition. He concluded with sharing an update from City Council on sound mitigation measures at the new pickleball courts in Bushmaster Park.

Parks and Recreation Councilmember Representative Anthony Garcia shared information about their search for a new City Manager and that there would be a public outreach opportunity coming up for the position. He added that if anyone had any questions, they were welcome to reach out to him.

8. Reports -- Monthly highlights of Parks and Recreation, Open Space, and Events

Sylvia Struss, Open Space Coordinator, shared a brief highlight on Weed Pull Wednesdays. She estimated that they had collected at least 80 weed pull bags just from Picture Canyon. She also shared information on upcoming Open Space events including:

- Flagstaff's celebration of Arbor Day on September 23rd. They would be planting three Honey Locust Trees in Thorpe Park with a fourth grade class from Marshall Elementary School.
- October 6th's full moon hike at Picture Canyon led by Ashlee Fliney.
- TarantulaTrek on October 5th at McMillan Mesa's Loop Trail.

The August 2025 newsletter was reviewed. The Commissioners thanked Sarah Holditch for her work on each monthly newsletter.

SUBJECT: Regional Plan Update

STAFF RECOMMENDED ACTION:

On Thursday, October 9, the Flagstaff City Council voted to adopt the Flagstaff Regional Land Use Plan 2045 with a list of Conditions of Approval and an Errata document. You can view a recording of the meeting at: https://www.youtube.com/watch?v=dT5vrGv9LbE. The Open Spaces Commission will review the City Council's decisions as they pertain to the Open Spaces Commission's recommendations.

Executive Summary:

The Conditions of Approval and Errata direct staff to make several edits to the plan. City Council discussed and modified the recommendations by the Planning & Zoning Commission, which first reviewed and refined these lists.

Conditions of Approval with Council Modifications: Council voted to modify the conditions by removing three conditions (#11, #47, and #64) and adding two conditions that the Planning & Zoning Commission had previously discussed (#80 and #99).

Errata, as approved by Council: The approved Errata included the list of corrections reviewed by the Planning & Zoning Commission with an additional five edits in Chapter 9 and two edits in Chapter 2, which were identified after P&Z approval.

Next Steps:

Regional Plan Special Election: The Regional Plan adoption process is not over. City residents will have the opportunity to vote on the Regional Plan in May 2026. First, a revised version of the plan, with changes from the Conditions of Approval and Errata, will be published online in November. In May 2026, a ballot by mail special election will be held, and the Regional Plan will be on the ballot for ratification as the City's General Plan. More information on the special election will be shared in the coming weeks. Coconino County residents will not directly vote on adopting the Regional Plan. The County Board of Supervisors will hold public hearings on adopting the Regional Plan as an amendment to the Coconino County Comprehensive Plan. The public hearing dates will be scheduled after adoption of the Comprehensive Plan.


