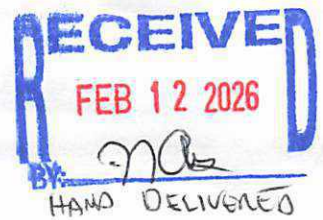


**PETITION TO FLAGSTAFF CITY COUNCIL**
