

ADDITIONAL SERVICES
SPECIFIC AUTHORIZATION

NO. 1

Pursuant to the provisions contained in the "Design Build Contract for RFP No. 2013-26 City Hall Wind Retro Fit Project - Expansion" between the City of Fort Pierce (hereinafter referred to as "CITY") and Wind Tech Products, Inc. (Hereinafter referred to as "CONTRACTOR") dated _____, authorizes the CONTRACTOR to provide services under the terms and conditions set forth herein and in the AGREEMENT, which is incorporated herein by reference as though set forth in full.

The CITY desires design build additional services related to, hereinafter referred to as the "Project".

Section 1 - Scope of Work

CONTRACTOR will provide the following services in accordance with this AGREEMENT at 110 N. 10th Street, St. Anastasia:

"Turn Key" material and installation, removal of existing exterior storefront systems and doors. Specific tasks under this authorization phase include:

TASK 1- Disposal of existing product

TASK 2 - Replacement of Impact Rated Systems, glass, and glazing

Section 2 Deliverables:

5. Field Verification
6. Project Manager

9. Jobsite daily cleaning
10. JeldWen Aluminum clad Hurricane Impact Window System

Section 3 - Time of Performance

Execution of this AGREEMENT shall constitute Notice to Proceed. CONTRACTOR and CITY agree the project will be completed no later than July 31, 2014.

Section 4 - Method and Amount of Compensation

4.1 CITY will compensate CONTRACTOR for services under this AGREEMENT in accordance with the payment method as set forth in Section 3 of the AGREEMENT.

4.2 The budget (or fee) for the required services is: \$1,388,260.00.

Section 5 - CITY's Responsibilities

CITY hereby designates City Manager or designee as CITY's representative pursuant to Section 10 of the AGREEMENT.

Section 6 - Other Provisions

All applicable portions of the AGREEMENT not specifically modified herein shall remain in full force and effect and are incorporated by reference.

IN WITNESS WHEREOF, this AGREEMENT, consisting of two pages, has been fully executed on behalf of the CONTRACTOR by its duly authorized officer, and the CITY has the same to be duly executed in its name and in its behalf, effective as of the date herein above written.
