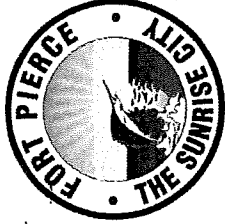

- All business tax receipts must be renewed by September 30 of each year to avoid a penalty.
