## HOTEL ACCOMMODATIONS - NEW LOCATION!

The **Embassy Suites Orlando - Lake Buena Vista South** (located at 4955 Kyngs Heath Road in Kissimmee) is the location for the 2015 Legislative Conference. The reservation cut-off date is **October 18, 2015**, and the rate is **\$149/night**. Each reservation includes a complimentary cooked-to-order breakfast and an evening reception. Self-parking is complimentary and valet parking is also available for \$12/day.

## DIRECTIONS

Take exit #68 and turn left onto S.R. 535 (S. Apopka/Vineland Road). Travel approximately 3.5 miles then turn right onto Kyngs Heath Road. The hotel is on the right and visible from S.R. 535.

### **I-4 Eastbound (Coming from Tampa, Clearwater)**

Take exit #68 and travel south on S.R. 535 (S. Apopka/Vineland Road). Travel approximately 3.5 miles then turn right onto Kyngs Heath Road. The hotel is on the right and visible from S.R. 535.

- ↩ 3. Turn left onto N 7th St 72 ft
- ↪ 4. Turn right onto FL-68 W/Orange Ave 4.3 mi
- ↩ 5. Turn left onto FL-713 S 2.4 mi
- ⤴ 6. Use the right 2 lanes to take the Florida's Turnpike ramp  
▲ Partial toll road 0.2 mi
- ↘ 7. Keep right at the fork and merge onto FL-91/Florida's Turnpike  
▲ Toll road 0.2 mi

### Follow FL-91/Florida's Turnpike to E Osceola Pkwy in Buena Ventura Lakes. Take exit 249 from FL-91/Florida's Turnpike

- ⤴ 8. Merge onto FL-91/Florida's Turnpike  
▲ Toll road 95.5 mi
- ↘ 9. Take exit 249 for Osceola Pkwy  
▲ Toll road 0.3 mi

### Continue on E Osceola Pkwy. Drive to Calypso Cay Way

15 min (7.1 mi)

- ↩ 10. Use any lane to turn left onto E Osceola Pkwy  
▲ Partial toll road 6.2 mi
- ↘ 11. Take the exit toward US-192/Resort Area/FL-535  
▲ Toll road 0.4 mi
