
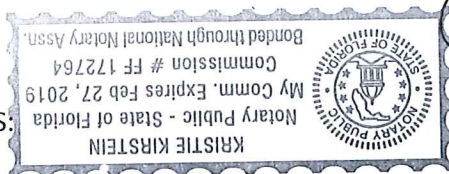

489.127(1.) (h) or 489.531(1.) (i) Commence or perform work for which a building permit is required pursuant to Part IV of Chapter 553 without such building permit being in effect.
489.127(1.) (i) or 489.531(1.) (j) Willfully or deliberately disregard or violate any municipal or county ordinance relating to uncertified or unregistered contractors.
489.531(1.) (a) Practice contracting unless the person is certified or registered.
489.531(1.) (b) Use the name or title "electrical contractor" or "alarm system contractor" or words to that effect, or advertise himself/herself or a business organization as available to practice electrical or alarm system contracting, when the person is not then the holder of a valid certification or registration issued pursuant to this part.
489.531(1.) (e) Employ persons who are not certified or registered to practice contracting.
489.531(1.) (h) Conceal information relative to violations of this part.

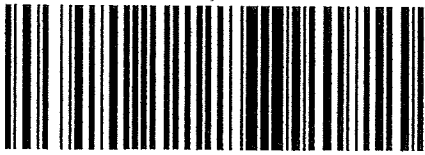

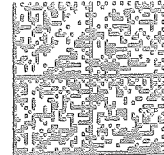
