

INTERLOCAL AGREEMENT FOR CONTRIBUTION

(Dan McCarty Middle School track)

THIS INTERLOCAL AGREEMENT is made and entered into as of the 9th day of March 2016 2015, by and between the SCHOOL BOARD OF ST. LUCIE COUNTY, governing body of the School District of St. Lucie County, Florida ("School Board"), and the CITY OF FORT PIERCE, a municipal corporation of the State of Florida ("City").

WITNESSETH

WHEREAS, the Florida Interlocal Cooperation Act of 1969, Section 163.01, Florida Statutes, permits local governmental units to make the most efficient use of their respective powers by enabling them to cooperate with one another on a basis of mutual advantage and thereby to provide services and facilities in a manner and pursuant to forms of governmental organization that will accord best with geographic, economic, population, and other factors influencing the needs and development of local communities; and

WHEREAS, the School Board owns certain lands located in St. Lucie County, Florida, more fully described in the attached Exhibit A ("Property"); and

WHEREAS, the School Board has developed a portion of Property as a track for Dan McCarty Middle School ("Track"); and

WHEREAS, the School Board plans to construct, and the City will provide construction administration for certain improvements for the Track ("Track Improvements"), which will improve the safety usability and efficiency of the Track for all participants and for the benefit of the community; and

WHEREAS, the City will administer the contract for the construction of the Track Improvements; and

WHEREAS, the School Board, and the City each agree to share in the total cost of designing, permitting, and constructing the Track Improvements, as outlined below.

NOW, THEREFORE, for and in consideration of these and other premises, the School Board, and the City hereby covenant and agree as follows:

1. Track Improvements.
 - (a) The City will perform the necessary construction administration of the project.
 - (b) The Track Improvements shall be constructed as follows:
 - (1). Leveling course and repaving track with 1 inch asphalt
 - (2) Restripe lane markers with 4 inch thermoplastic paint
 - (3) Replace existing lights with new LED lights

(c) The School Board shall contribute nineteen thousand dollars (\$19,000) of the total project cost and the City shall contribute twenty three thousand dollars (\$23,000) of the total project cost. The School Board shall make such payments to the City not later than thirty (30) days after the notice to proceed is issued by the City and the School Board is invoiced.

2. Maintenance. The School Board shall be responsible for maintaining the Track after the Track Improvements are completed.

3. Operation: The School Board will make the track available and open for public use at times that are not in conflict with the School Board's regular use of the track for school operations. The School Board shall have the sole and exclusive right to determine the days and times that the track is open for public use and shall have the right to both modify the days and times for public access to the track at any time and to temporarily suspend public access to the track.

4. Amendment. This Agreement may only be amended by written document signed by both parties and filed with the Clerk of the Circuit Court of St. Lucie County, Florida.

5. Notice. Until further written notice by either party to the other, all notices provided for in this Agreement shall be in writing and transmitted by messenger, mail, or facsimile transmission, and if to the School Board, shall be mailed or delivered to the School Board at:

5. Recording of Agreement. Upon execution of this Agreement, the School Board shall, at the School Board's expense, cause this Agreement to be recorded with the Clerk of the Circuit Court of St. Lucie County, Florida.

6. Effective Date. This Agreement shall be effective upon filing with the Clerk of the Circuit Court of St. Lucie County, Florida, in accordance with Section 163.01(11), Florida Statutes.

7. Venue. Venue of any action to enforce the terms of this Agreement shall be in St. Lucie County if filed in state court, and in the Southern District of Florida if filed in federal court.

8. Entire Agreement. This Agreement constitutes the entire agreement between the parties with respect to the subject matter hereof and supersedes all prior oral or written agreements between the parties with respect thereto.

9. Counterparts. This Agreement may be executed in several counterparts, each of which shall be considered an original.

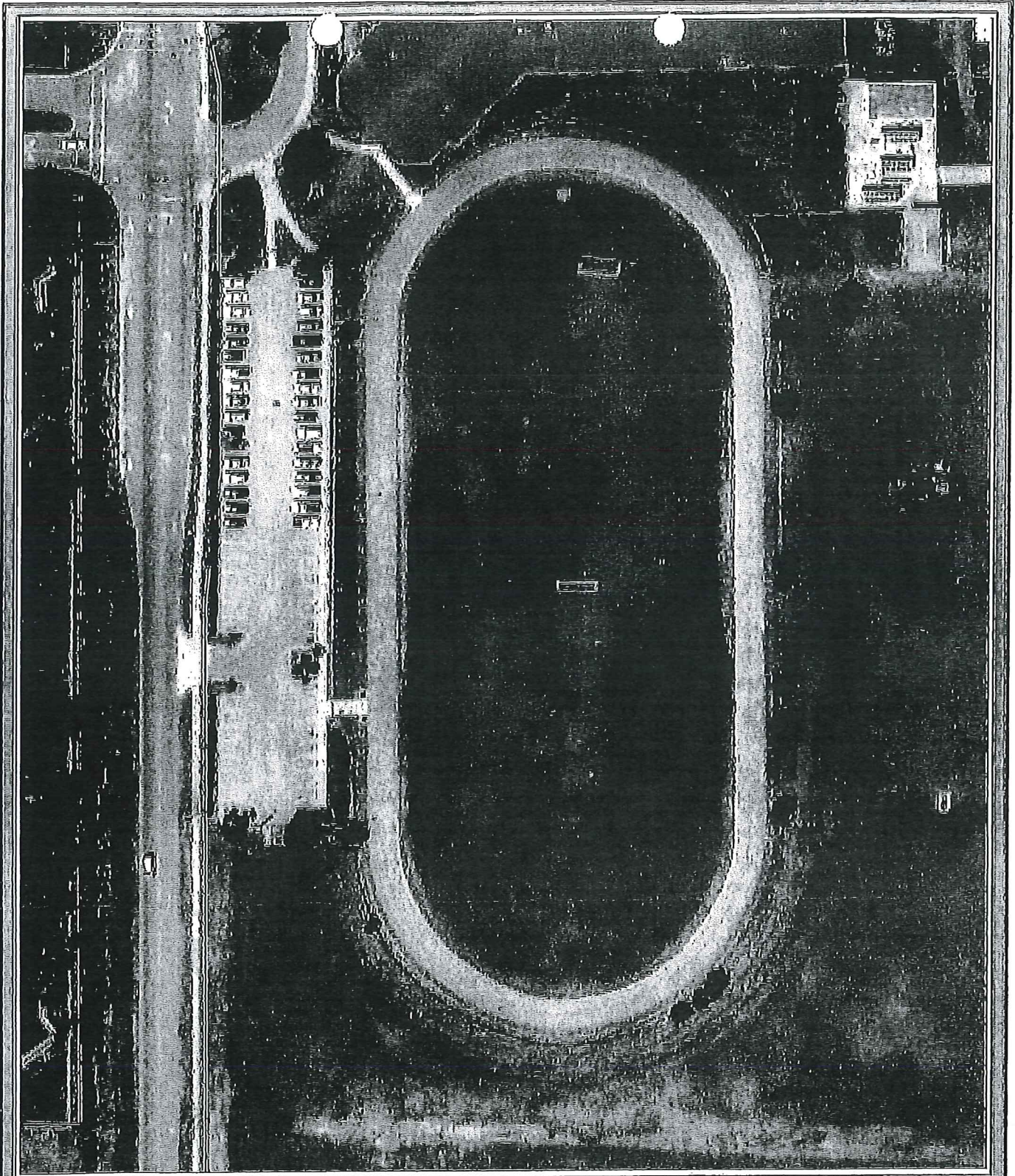

PROPERTY DESCRIPTION

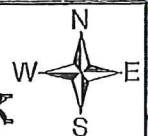
