NOTICE OF LACK OF PROSECUTION AND NOTICE OF HEARING

PLEASE TAKE NOTICE that it appears on the face of the record that no activity by the filing of pleadings, order of court, or otherwise has occurred for a period of 10 months immediately preceding service of this notice, and no stay has been issued or approved by the court. Pursuant to Rule 1.420(e), if no such record activity occurs within sixty (60) days following the service of this notice, and if no stay is issued or approved during such sixty (60) day period, this action may be dismissed by the court on its own motion or on the motion of any interested person, whether a party to the action or not, after reasonable notice to the parties, unless a party shows good cause in writing at least 5 days before hearing on the motion why the action should remain pending

If there is no record activity as described above within sixty (60) days of receipt of this notice and if no stay is issued or approved prior to the expiration of the sixty (60) day, a hearing on the Court's Motion to Dismiss for Lack of Prosecution shall be held on December 1 2016 at 09:30 AM before the Honorable WILLIAM L ROBY, Circuit Judge, Courtroom 3E of the St Lucie County Courthouse, located at 218 South 2nd Street, Fort Pierce, FL 34950. Good cause shall be shown why the action should not be dismissed for lack of prosecution at least five (5) days prior to the hearing set forth above. The showing of good cause shall be in writing and filed in the action. Failure to file a written showing of good cause shall result in this case being dismissed.

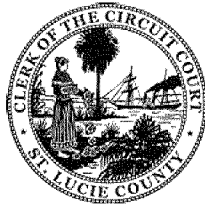
