

RESOLUTION NO. 12-40

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT PIERCE, FLORIDA, SUPPORTING THE APPLICATION FOR A FLORIDA FISH AND WILDLIFE CONSERVATION COMMISSION BOATING INFRASTRUCTURE GRANT FOR THE DESIGN AND CONSTRUCTION OF TRANSIENT DINGHY DOCKS AT THE CITY MARINA; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Fort Pierce City Marina lacks public transient boat slips, which severely impacts the availability of safe access to historic downtown amenities for transient, non-trailerable boaters; and

WHEREAS, the City Commission of the City of Fort Pierce recognizes this deficiency and is interested in pursuing funding for the design and construction of public dinghy docks, which will include tie-up facilities for the temporary use by dinghies from transient non-trailerable recreational vessels; and

WHEREAS, the City of Fort Pierce intends to build these tie-up facilities on navigable waters, available to the public, and design the new construction to last at least 20 years; and


WHEREAS, the City of Fort Pierce desires to apply for a Florida Fish and Wildlife Conservation Commission (FWC) Boating Infrastructure Grant to provide funding for a project that offers value-added amenities for the regional boating community and provides an important stimulus for economic revitalization for the historic downtown.

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of Fort Pierce, Florida, as follows:


SECTION 1. The City Commission of the City of Fort Pierce, Florida, authorizes the Manager of the Fort Pierce City Marina, serving as the Project Manager, to apply for an FWC Boating Infrastructure Grant for the purpose of funding the design and construction of transient dinghy docks at the Fort Pierce City Marina on behalf of the City of Fort Pierce.

SECTION 2. This Resolution shall take effect immediately upon adoption.
