








I, as an affected party, am requesting the Ft. Pierce City Council to **DENY** application for Site Plan, Conditional Use, and Design Review for in-patient treatment center for **Drug & Alcohol Treatment at 604 Midway Road, Fort Pierce, FL**, Parcel ID: 3403-243-0001-000-0, which is a property zoned Office Commercial, C-1.

If the Ft. Pierce City Council does not feel they are in a position to deny at this time, the citizens of White City are **requesting a continuance of this hearing**, to provide time for the developer and city staff to meet with members of the community and address concerns.

This requested 'conditional use' is inconsistent with the comprehensive plan and zoning for this area, is seriously incompatible with the surrounding community, is highly likely to degrade the quality of life, sense of place, and sense of safety for residents, has not proven a need with at least 44 detoxification / substance treatment centers in county and 22 within 6 mile radius of proposed site.

In addition, this proposal was not properly noticed to this community, which includes a property owners' organization able to make community members aware of this proposal. Notice was limited 15 entities only, who are within 500 feet of the proposed site. The public hearing sign placed at the property was not appropriately sized to effectively and honestly attempt to notify the community, as major construction and altered traffic patterns made it dangerous for drivers to recognize signage. A proposal of this potential impact should require due diligence and a higher level of consideration and notice within the community, extending notification of residents beyond 500 feet, including notification to community organization representing citizens, and use of oversized hearing notice on property.

Finally, by denying this proposal, the Council shows an understanding of the White City community, represents stewardship and preservation of this historical community and its citizens, and does not take any permittable rights away from this landowner nor developer.

White City residents face serious challenge to their way of life.

This TOXIC proposal goes before the Fort Pierce City Commission Meeting for a FINAL HEARING this
Monday, August 7th @ 6:30pm
City Hall - City Commission Chambers, 100 North U.S. #1, Fort Pierce, Florida

White City is a small bedroom community with a rich 120 year history. It has long been a coveted area to live, and while filled with small modest homes on relatively large lots, demands top dollar to have the honor of living in a place that affords residents room to breathe.

This way of life is being seriously threatened by a new development proposal for a residential Detox Center across the street from Nelson's Family Farm. This Center would be a 3 story structure with 180 beds for short term (2 week) treatment potentially reaching almost 5,000 per year. The business plan from this out-of-town developer is not focused on treating St. Lucie County residents, but instead bringing people in from across the country to spend 2-weeks detoxing in our neighborhood. What then? After 2 weeks, with a generally high failure rate, where do they go?

This proposal is incompatible and inconsistent with the character of our community. Do people need help? Absolutely. Are there more appropriate locations for detox facilities? Yes. Is a quiet, historic, bedroom community an appropriate location for these facilities? Absolutely NOT!

The developer would like to say that its neighbors are a dental office, retail, conservation area, and an empty lot. The truth is that commercial property makes up one lot along the roadway, a strip of land. Beyond that in almost every direction are established neighborhoods, churches, public and private schools ... and again, our coveted way of life!

Currently St. Lucie County has a minimum of 44 detox facilities already, 22 of which are in a 5-mile radius of this proposed center. Therefore, 'need' has not been established.

This out-of-town developer is asking Ft. Pierce City Commission to approve a **conditional use permit**. What this means is that they are asking for 'special treatment' to allow a zoning exception to develop in a way not otherwise permitted within the zoning established for this area. It's an easy NO. The developer shouldn't have an expectation to receive special treatment, and cannot contend that his land rights were taken away.

Even with this being true, the Planning Board recommended approval and the City planning staff is recommending approval. **THIS IS THE FINAL HEARING.** If citizens don't come out in force, e-mail or write the council, or sign the petition, it is very likely this proposal will be approved.

What can you do?



Pierce City Council to **DENY** application for Site Plan, Conditional Use, and Design Review for in-patient treatment center for **Drug & Alcohol Treatment at 604 Midway Road, Fort Pierce, FL**, Parcel ID: 3403-243-0001-000-0, which is a property zoned Office Commercial, C-1.

If the Ft. Pierce City Council does not feel they are in a position to deny at this time, the citizens of White City are **requesting a continuance of this hearing**, to provide time for the developer and city staff to meet with members of the community and address concerns.

This requested 'conditional use' is inconsistent with the comprehensive plan and zoning for this area, is seriously incompatible with the surrounding community, is highly likely to degrade the quality of life, sense of place, and sense of safety for residents, has not proven a need with at least 44 detoxification / substance treatment centers in county and 22 within 6 mile radius of proposed site.

In addition, this proposal was not properly noticed to this community, which includes a property owners' organization able to make community members aware of this proposal. Notice was limited 15 entities only, who are within 500 feet of the proposed site. The public hearing sign placed at the property was not appropriately sized to effectively and honestly attempt to notify the community, as major construction and altered traffic patterns made it dangerous for drivers to recognize signage. A proposal of this potential impact should require due diligence and a higher level of consideration and notice within the community, extending notification of residents beyond 500 feet, including notification to community organization representing citizens, and use of oversized hearing notice on property.

Finally, by denying this proposal, the Council shows an understanding of the White City community, represents stewardship and preservation of this historical community and its citizens, and does not take any permittable rights away from this landowner nor developer.
