Continuing Education in Ethics: Have You Completed Your Hours?

Florida's municipal elected officers are required to take four specific hours of continuing education in ethics per year. If you haven't completed your hours yet, this is your opportunity! The four hours include two hours on the Florida Ethics Law (Chapter 112, F.S.), one hour of public meetings (Chapter 286, F.S.) and one hour of public records (Chapter 119, F.S.). If your hours are completed, this is a good refresher class.

NOTE: You must be registered for the full conference to attend this session and pre-registration is required. Registration is limited to the first 40 people. See the registration form for details.

Then 0.05 miles 0.05 total miles

2. Turn left onto Avenue A.

If you reach Avenue B you've gone a little too far.

Then 0.16 miles 0.21 total miles
- 


3. Turn left onto N 7th St.

First United Methodist Church is on the corner.

Then 0.01 miles 0.23 total miles
- 

4. Take the 1st right onto Orange Ave/County Hwy-68.


First United Methodist Church is on the corner.

Then 0.52 miles 0.74 total miles
- 

5. Turn left onto S 13th St.

S 13th St is just past Alma Ct.


If you reach N 14th St you've gone a little too far.

Then 0.25 miles 0.99 total miles
- 

6. Take the 2nd right onto Delaware Ave/FL-70. Continue to follow FL-70.


FL-70 is just past Citrus Ave.

If you reach Easter Ave you've gone a little too far.


Then 4.45 miles 5.44 total miles
- 

7. Merge onto FL-91 N/Florida's Tpk N via the ramp on the left toward Orlando (Portions toll).


If you reach S Rock Rd you've gone about 0.1 miles too far.

Then 89.48 miles 94.92 total miles
- 


8. Take the US-192/US-441 exit, EXIT 242, toward Kissimmee/St Cloud.

Then 0.35 miles 95.27 total miles
- 

9. Keep left to take the ramp toward Kissimmee/Disney World/Osceola Co Stadium.


Then 0.03 miles 95.29 total miles
- 

10. Turn left onto E Irlro Bronson Memorial Hwy/US-441 N/US-192 W. Continue to follow US-192 W.

Then 11.47 miles 106.77 total miles
- 


11. Turn right onto State Road 535/FL-535.

State Road 535 is 0.1 miles past Sunward Dr.

Then 0.20 miles 106.97 total miles
- 

12. Turn left onto Kyngs Heath Rd.

If you are on FL-535 and reach Calypso Cay Way you've gone about 0.2 miles too far.

Then 0.09 miles 107.06 total miles
- 

13. 4955 Kyngs Heath Rd, Kissimmee, FL 34746-5512, 4955 KYNGS HEATH RD is on the right.

If you reach Sadina St you've gone a little too far.

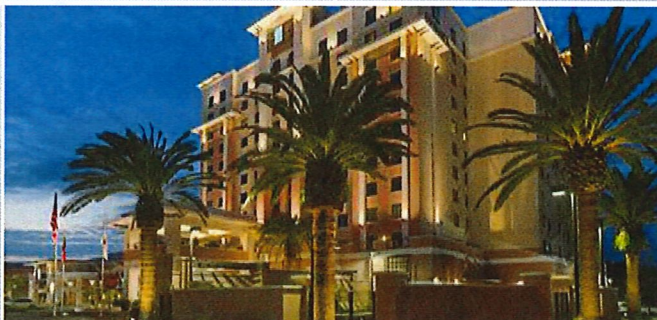
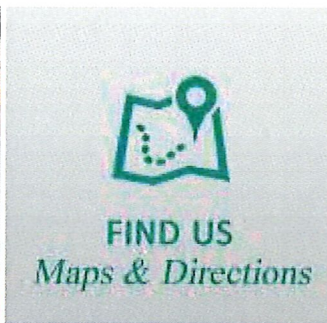
