KNOW ALL MEN BY THESE PRESENTS, THAT CDA HOLDINGS, LLC, FEE SIMPLE OWNER OF THE LANDS SHOWN HEREON, BEING A PARCEL OF LAND LYING IN SECTION 17, TOWNSHIP 35 SOUTH, RANGE 40 EAST, ST. LUCIE COUNTY, FLORIDA, AND SHOWN HEREON AS DOLLAR TREE AT OKEECHOBEE AND HARTMAN.

BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCE AT THE SOUTHWEST CORNER OF SAID SECTION 17; THENCE NORTH 01°20'45" EAST, ALONG THE WEST LINE OF SAID SECTION 17, A DISTANCE OF 816.39 FEET; THENCE NORTH 89°46'21" EAST, A DISTANCE OF 45.01 FEET TO THE SOUTHWEST CORNER OF THE LANDS SHOWN IN OFFICIAL RECORD BOOK 2850, PAGE 2776, AS RECORDED IN THE PUBLIC RECORDS OF ST. LUCIE COUNTY, FLORIDA, AND THE POINT OF BEGINNING; THENCE CONTINUE NORTH 89°46'21" EAST, A DISTANCE OF 393.41 FEET TO A POINT ON THE WEST LINE OF LANDS SHOWN IN OFFICIAL RECORD BOOK 466, PAGE 448, OF THE PUBLIC RECORDS OF ST. LUCIE COUNTY, FLORIDA; THENCE SOUTH 04°40'55" EAST, A DISTANCE OF 267.25 FEET TO A POINT ON THE NORTH RIGHT OF WAY OF OKEECHOBEE ROAD; THENCE SOUTH 77°41'18" WEST, ALONG SAID RIGHT OF WAY LINE, A DISTANCE OF 145.11 FEET TO A THE BEGINNING OF A CURVATURE CURVE CONCAVE TO THE SOUTH, HAVING A CENTRAL ANGLE OF 25°08'56" AND A RADIUS OF 500.00 FEET; THENCE RUN ALONG WESTERLY ALONG THE ARC OF SAID CURVE FOR AN ARC DISTANCE OF 219.46 FEET TO A POINT OF TANGENCY; THENCE SOUTH 52°32'22" WEST, ALONG SAID RIGHT OF WAY, A DISTANCE OF 69.77 FEET TO A BEGINNING OF A CIRCULAR CURVE CONCAVE TO THE NORTHEAST, HAVING A CENTRAL ANGLE OF 128°48'22" AND A RADIUS OF 25 FEET; THENCE RUN WESTERLY, NORTHWESTERLY ALONG THE ARC OF SAID CURVE, A DISTANCE OF 56.20 FEET; THENCE NORTH 88°39'15" WEST, A DISTANCE OF 10.00 FEET TO A POINT THAT LIES 25 FEET EAST OF THE WEST LINE OF THE SOUTHWEST 1/4 OF SAID SECTION 17; THENCE NORTH 01°20'45" EAST, ALONG THE EAST RIGHT OF WAY LINE OF HARTMAN ROAD, A DISTANCE OF 61.92 FEET; THENCE NORTH 89°46'21" EAST, A DISTANCE OF 20.01 FEET; THENCE NORTH 01°20'45" EAST, A DISTANCE OF 347.23 FEET TO THE POINT OF BEGINNING.

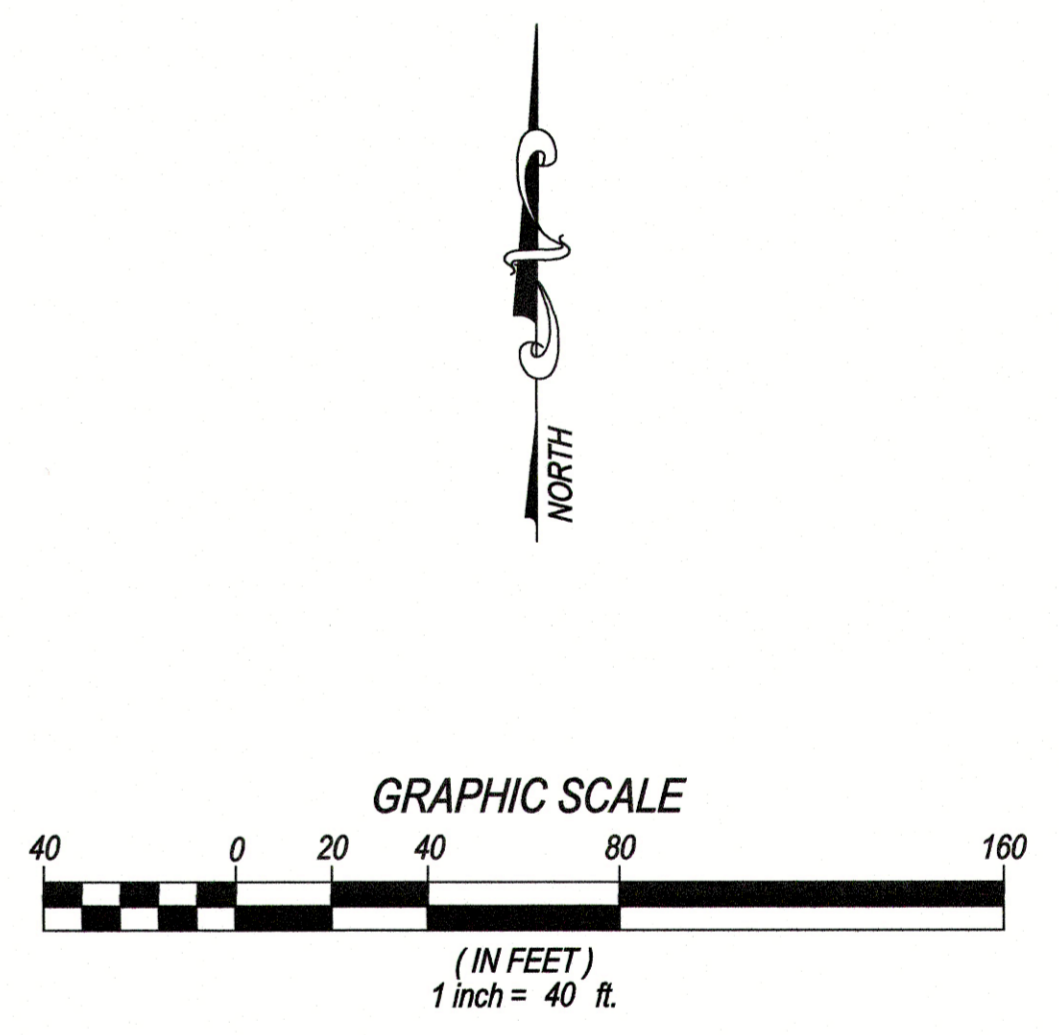
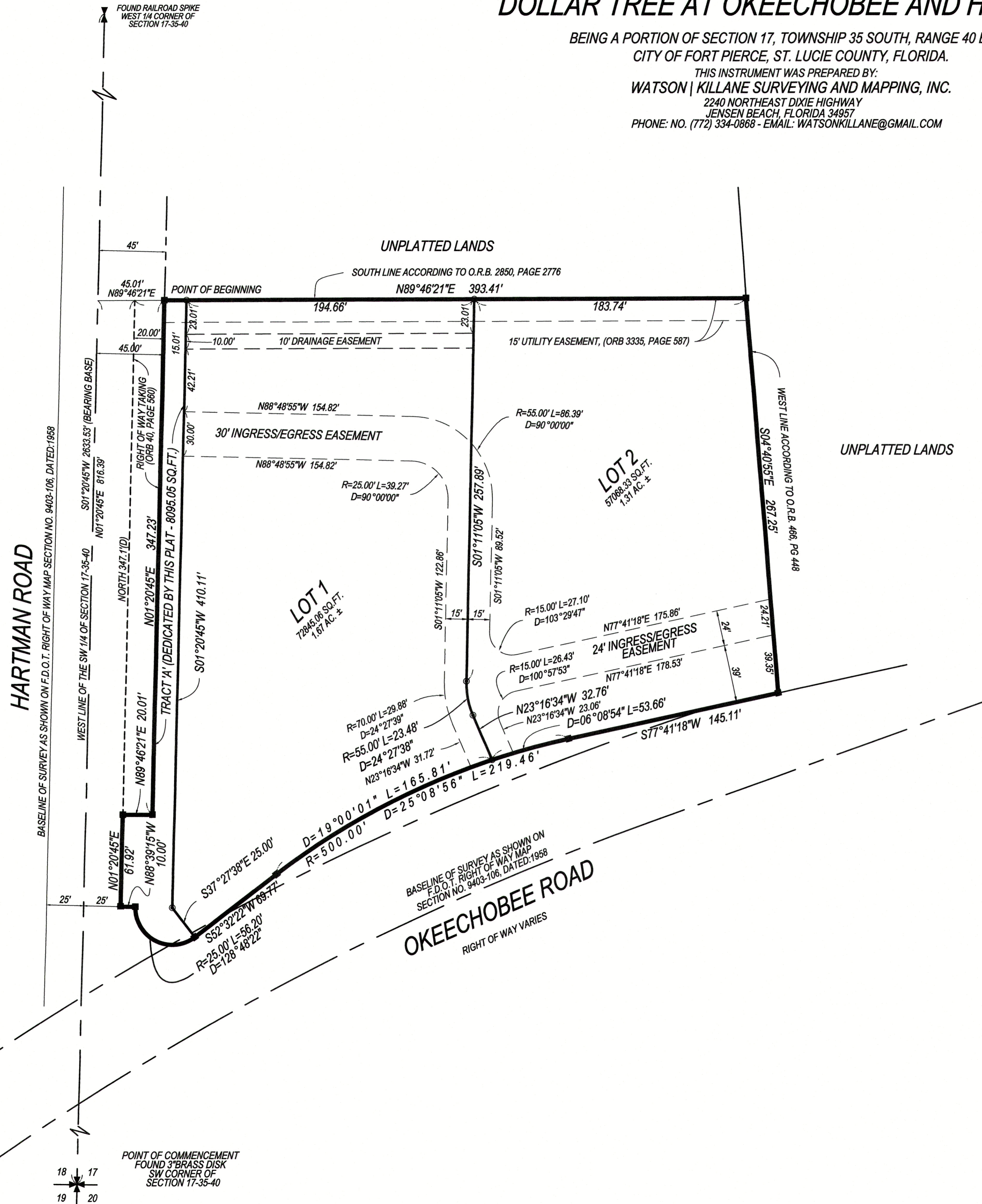
