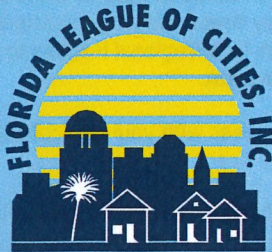

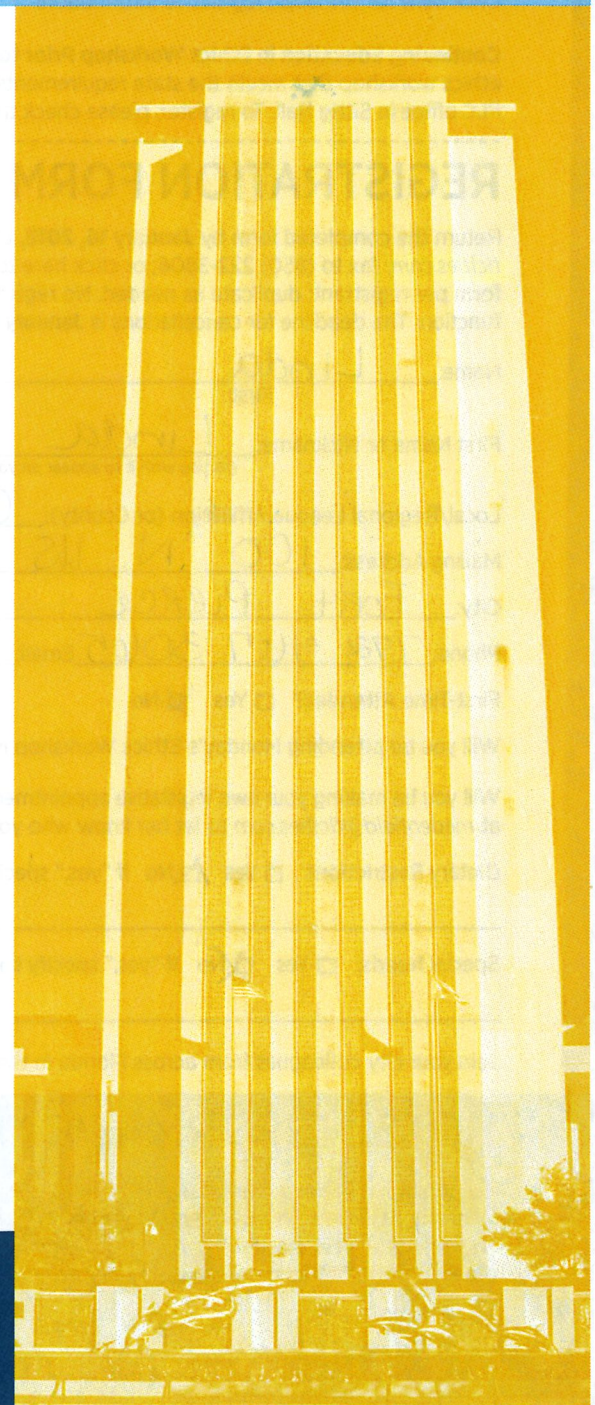

2018 FLC LEGISLATIVE ACTION DAYS



The Florida League of Cities' Legislative Action Days will be held **Tuesday and Wednesday, January 30-31, 2018**, in Tallahassee. Hotel space is limited in Tallahassee during session, so make your travel plans now!

Be part of this year's advocacy efforts as President Gil Ziffer and the League's legislative team strategize and prepare for this critical session. You'll hear directly from key legislators on an array of important issues.

The event begins on **Tuesday, January 30** with a legislative briefing at 10:00 a.m. in Sittig Hall, located in the Florida League of Cities office, followed by a legislative luncheon from 11:45 a.m. until 1:30 p.m. at the Doubletree Hotel. Learn the latest on key issues affecting municipalities. After lunch, plan to visit the Capitol for scheduled meetings with your legislators. League staff will work with local/regional leagues to coordinate and schedule appointments. **Please indicate your local/regional league on the attached registration form.**

There will be a reception Tuesday evening for all registrants, beginning at 6:00 p.m. at the FLC office. Share ideas with your city colleagues and legislators in a relaxed setting.

On **Wednesday, January 31**, plan to continue meetings with your legislators in the morning.
