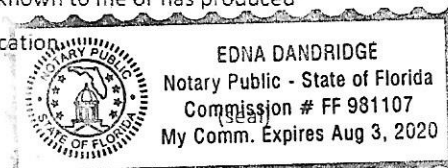

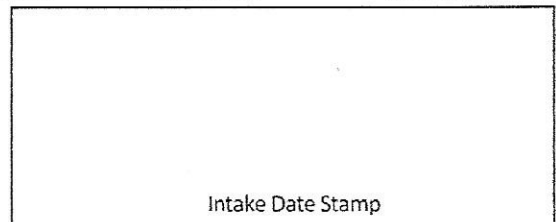

A PARCEL OF LAND KNOWN AS AVENUE C RIGHT OF WAY TO BE ABANDONED.

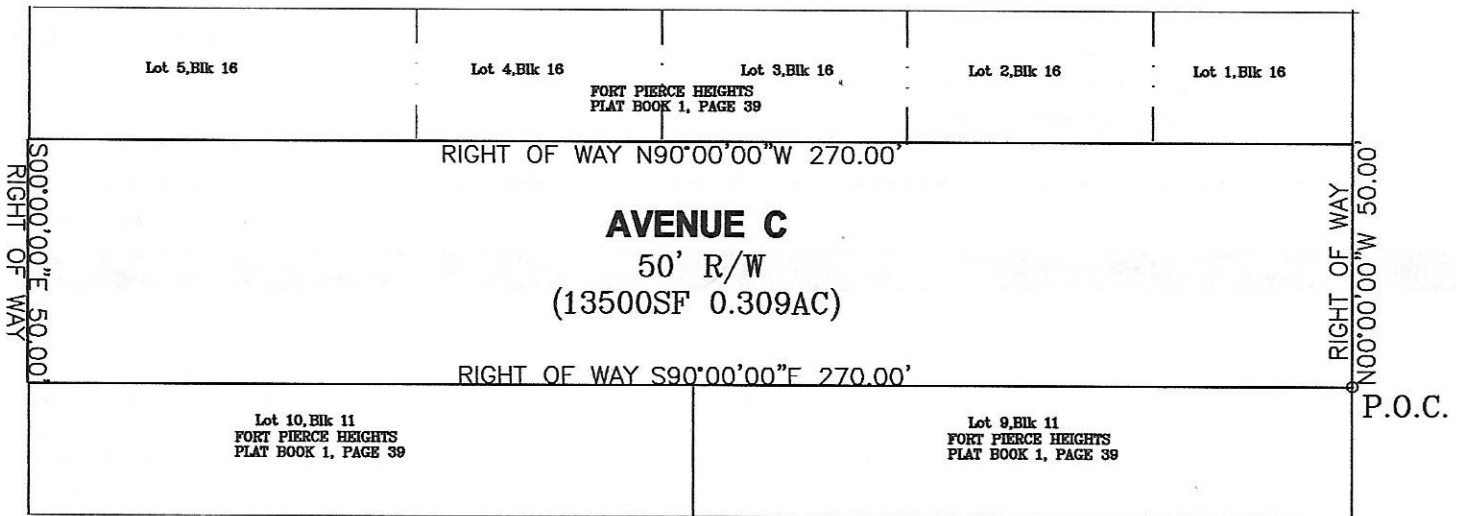
