

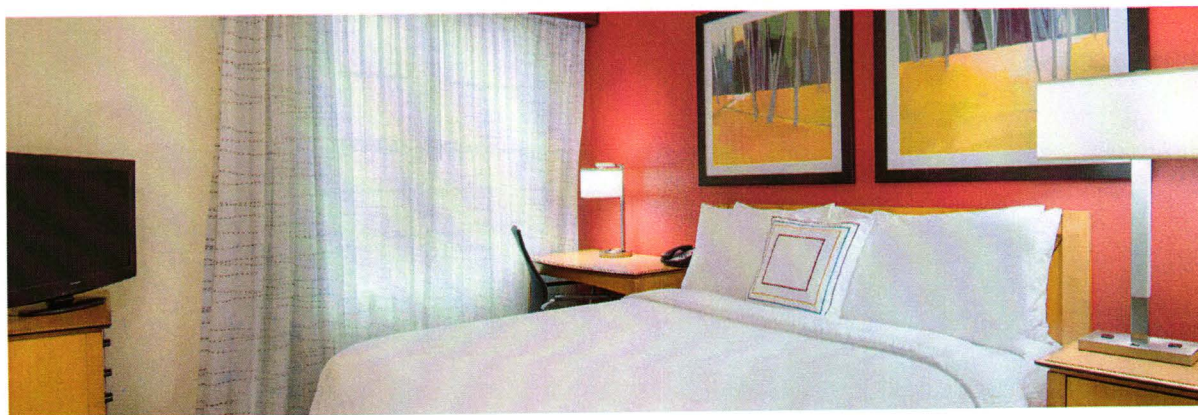

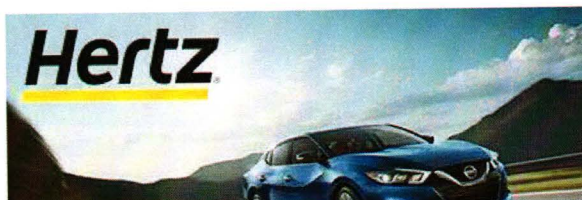

1. Start out going **northwest** on N US Highway 1/US-1 N/FL-5 toward US-1 S.  
Then 0.05 miles ..... 0.05 total miles

2. Turn **left** onto Avenue A.  
*If you reach Avenue B you've gone a little too far.*  
Then 0.16 miles ..... 0.21 total miles

3. Turn **left** onto N 7th St.  
Then 0.01 miles ..... 0.23 total miles


4. Take the 1st **right** onto Orange Ave/County Hwy-68.  
Then 0.52 miles ..... 0.74 total miles

5. Turn **left** onto S 13th St.  
*S 13th St is just past Alma Ct.*  
*If you reach N 14th St you've gone a little too far.*  
Then 0.25 miles ..... 0.99 total miles

6. Take the 2nd **right** onto Delaware Ave/FL-70. Continue to follow FL-70.  
*FL-70 is just past Citrus Ave.*  
*If you reach Easter Ave you've gone a little too far.*

7. Merge onto Florida's Turnpike/FL-91 S via the ramp on the **left** toward **Miami**  
(Portions toll).  
*If you reach S Rock Rd you've gone about 0.1 miles too far.*

8. Keep **right** at the fork to go on Florida's Turnpike (Portions toll).  
Then 17.78 miles ..... 86.89 total miles


 **9. Merge onto Sawgrass Expy/FL-869 S via EXIT 71 toward Coral Springs/Key West** (Portions toll).  
..... Then 22.69 miles ..... 109.58 total miles


 **10. Sawgrass Expy/FL-869 S becomes I-75 S.**

 **11. Take the Miramar Pkwy exit, EXIT 7.**

 **12. Merge onto Miramar Pkwy via the ramp on the left.**

 **13. Turn left onto SW 148th Ave.**

23. Merge onto Florida's Turnpike/FL-91 N via EXIT 21B toward **Orlando**

24. Keep **right** at the fork to go on Florida's Turnpike (Portions toll).

25. Merge onto FL-70 E via EXIT 152 toward **Ft Pierce/I-95/Indian River College/US-1.**

26. Turn **left** onto S 4Th St/US-1 N/FL-5. Continue to follow US-1 N/FL-5.
