On 02/02/19, at 1517 hours, I was dispatched to True Food Restaurant located at 1721 Ave D in reference to a disturbance. Dispatch advised a customer was refusing to pay for there food and is attempting to leave but the owner is preventing him from leaving.

Upon arrival Officer Lawrence advised the suspect was a white male wearing a white shirt and white shorts with a thin build last seen heading westbound.

Upon my arrival contact was made with Vincent Barnett, the owner of True Food. Mr. Barnett explained a unknown white male customer ordered food then after eating advised he wasn't going to pay for the food and attempted to leave. Mr. Barnett said he then called 911 and prevented the male from leaving by blocking the door with his body. Mr. Barnett said the male then took a knife out and threatened for Mr. Barnett to let him leave. After the male forced his way through Mr. Barnett, the knife was dropped on the ground.

A large knife was located at the entrance of the True Food, still in the leather sheath.

I then spoke to two customers, a male and a female that witnessed the incident. Both refused to provide there names but there statements where captured on BWC. The male advised he heard the male state "I aint paying for shit". The owner then prevented the male from leaving the restaurant during which the white male forced his way through dropping his knife in the sheath before making his way out the door. The witness advised the knife was never used in a threatening manor and pointed out that the knife is still in its sheath.

The female witness advised the white male said he was not going to pay for his food and then headed for the door to leave the restaurant. The owner then prevented the male from leaving during which a knife the male had on his person fell to the ground. The witness advised the male never threatened the owner with the knife.

The white male was unable to be located after canvassing the area, at this time there is insufficient evidence to support a crime was committed. The knife was collected and submitted into evidence as found property. Sworn statement from Mr. Barnett was submitted into evidence, BWC footage is available.

On 08/10/15 at approximately 1332 hours I responded to 1721 Avenue D in reference to a theft. Upon arrival I met with an adult male (identified as Vincent Barnett). Mr. Barnett stated he is the owner of 1721 Avenue D (The Spot Restaurant).

Mr. Barnett stated the following: He was working at the restaurant on Sunday 08/09/15 until approximately 1700 hours. He then left two partners in charge of the business. The business was open until approximately 0500 Monday (08/10/15) morning. There were people in and out of the business at all hours of the night as it was open. At approximately 1200 hours on 08/10/15, Mr. Barnett returned to the restaurant to open for business. He then discovered his State License (\$680), Occupational License (\$75) and Tax ID (\$5) were missing. Barnett immediately called and who both stated they knew nothing about the missing licenses. The licenses were attached to the rear (southeast wall) with tape. There are no surveillance cameras in the business. There is no suspect information at this time.
