- a. Discussion on Unity in the Community to be held on July 11, 2019.

Unity in the Community July 11th

Member Hayek inquired on ways the Committee can be more proactive/visible to help the relationship between the community and the Police Dept. Staff suggested having a table at the Unity in the Community event, for attendees that may want to meet or have questions for members of the committee. Member Hendley expressed it would be an excellent opportunity for introduction to the community. Staff proposed community meetings in Districts 1 and 2 for citizens to meet committee members. Further discussion included ways of trying to get the adult population to attend Unity in the Community, since services, including health checks, are being offered there.

Bethune Cookman Engagement Program

Staff discussed Bethune Cookman Community Engagement program where they act as moderators between citizens and Officers, where Police Officers and residents can learn more about each other. Once plans have been finalized the Committee will be brought into it to be a part of the conversation.

Role of PCAC in Community

Members and Staff discussed ways to combat stigma of the City being divided by the bridge, that we should be one city, one united. Members spoke about being invited to any community activity that is happening; crime watch meetings, concerned citizen meetings, neighborhood watch meeting. Staff suggested starting a newspaper that citizens sign up for by email, to showcase the Department and their accomplishments, and the Advisory Board can be included.

Members and Staff discussed possibility of getting a slot on the City Commission meeting for the Chief or a Member to give an update on positives that are happening within the Police force, to include promotions, Unity in the Community and other activities organized by the Police Department. Members proposed also speaking with and getting information to their individual commissioners, to update the community so they can see the Police Department in a vein different than when Officers are responding to a crises. That citizens may not always here this information on the radio.

- b. Discussion on how to handle the conflict with Unity in the Community and the next Police Community Advisory Committee meeting date.

Staff also discussed Summer of Success, where children are given training on different job functions, and also a volunteer opportunity through Catholic Volunteers at the Police Department.

Mental Health, Homelessness and PCAC Availability to Officers

Members and Staff spoke of ways Officers can make contact with PCAC Members about concerns they may have. Members' contact information will be made available to Officers, and Police Supervisors' contact information will be available to Members. Member expressed concern for assistance available to Officers who may be in crisis and Staff advised that information was presented at roll calls that help is readily available to Officers.
