

**FIRST AMENDMENT TO INTERLOCAL AGREEMENT  
FOR OPERATON OF TEMPORARY ANIMAL SHELTER**

**THIS FIRST AMENDMENT TO INTERLOCAL AGREEMENT FOR OPERATION OF TEMPORARY ANIMAL SHELTER** is made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, 2020, by and between **ST. LUCIE COUNTY**, a political subdivision of the State of Florida, by and through its Board of County Commissioners (referred to hereinafter as "County"), and the **CITY OF FORT PIERCE**, a municipal corporation of the State of Florida, (referred to hereinafter as "Fort Pierce"), by and through its City Commission.

**WITNESSETH:**

**WHEREAS**, Section 163.01, Fla. Stat. (2019), the "Florida Interlocal Cooperation Act of 1969," provides that local governments, or public agencies, may cooperate by agreement with one another to provide services and facilities that will best meet the needs of local communities; and

**WHEREAS**, the above-named governmental entities are public agencies as that term is defined in Section 163.01(3)(a), Fla. Stat. (2019) referred to hereinafter as the "party" or "parties"; and

**WHEREAS**, on October 1, 2019, the parties and the City of Port St. Lucie entered into an Interlocal Agreement for Operation of Temporary Animal Shelter recorded in Official Records Book 4339 at Page 2584 of the public records of St. Lucie County, Florida, hereinafter referred to as the "Agreement"; and,

**WHEREAS**, the Agreement provided for an original term through and including March 31, 2020, subject to extension upon agreement of the parties; and,

**WHEREAS**, the City of Port St. Lucie has entered into a separate agreement for animal shelter services and, accordingly, is no longer a party to the Agreement effective March 31, 2020; and,

**WHEREAS**, Fort Pierce and the County desire to extend the term of the Agreement through and including June 30, 2020, pending renovation of the animal shelter located at 100 Savannah Road, Fort Pierce, Florida, and the selection of a third party to operate the shelter once renovated

**NOW, THEREFORE**, the parties hereby agree and covenant on the terms and conditions hereinafter stated:

1. The parties acknowledge and agree that the City of Port St. Lucie is no longer a party to the Agreement effective March 31, 2020, and any references to the City of Port St. Lucie in the Agreement shall be without effect following such date.

2. Paragraph 3, SAVANNAH SHELTER, of the Agreement is amended to read as follows:

3. **SAVANNAH SHELTER.** On or before April 21, 2020, or as soon thereafter as practicable, the parties shall enter into a separate Interlocal Agreement for the renovation and operation of the Savannah Road Animal Shelter.

3. Paragraph 6, Term; Termination, of the Agreement is amended to read as follows:

6. **TERM; TERMINATION.** This agreement shall be effective on the date it is recorded in the public records of St. Lucie County, Florida, and shall remain effect

through and including July 1, 2020, unless extended or terminated as herein provided. This agreement may be extended or terminated upon the mutual agreement of the parties.

4. This First Amendment to the Agreement shall take effect upon being recorded in the public records of St. Lucie County, Florida.
