

**RESOLUTION 20-R22**

A RESOLUTION OF THE CITY OF FORT PIERCE, FLORIDA **SUPPLEMENTING ITS RESOLUTION NO. 20-R21** BY AMENDING ALL REFERENCES TO CAPITAL IMPROVEMENT REVENUE NOTE, SERIES 2014A TO CAPITAL IMPROVEMENT REVENUE NOTE, SERIES 2014; PROVIDING FOR SEVERABILITY AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, the City Commission of the City of Fort Pierce, Florida (the "City") on April 20, 2020 adopted City Resolution No. 20-R21 (the "Initial Resolution") which Initial Resolution among other matters authorized the refunding of the City's Outstanding Capital Improvement Revenue Note, Series 2014A (the "2014A Note"); and

**WHEREAS**, as set forth in information presented at such April 20, 2020 City Commission meeting it was the intent of the City to refund its Capital Improvement Revenue Note, Series 2014 rather than the 2014A Note.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT PIERCE, FLORIDA, as follows:**

SECTION 1. Supplement. All references in the Initial Resolution to the 2014A Note are herein amended to the City's Capital Improvement Revenue Note, Series 2014.

SECTION 2. Inconsistent Resolutions and Motions. All prior resolutions of the District inconsistent with the provisions of this Resolution are hereby modified, supplemented and amended to conform with the provisions herein contained and, except as so modified, supplemented and amended hereby, shall remain in full force and effect.

SECTION 3. Severability. If any section, paragraph, clause or provision of this Resolution shall be held to be invalid or ineffective for any reason, the remainder of this Resolution shall continue in full force and effect, it being expressly hereby found and declared that the remainder of this Resolution would have been adopted despite the invalidity or ineffectiveness of such section, paragraph, clause or provision.

SECTION 4. Effective Date. This Resolution shall become effective immediately upon its adoption.
