

The City Commission of the City of Fort Pierce, Florida, pursuant to Section 22-142 of the Code of Ordinances of the City of Fort Pierce, will on Monday, July 6, 2020 hold Public Hearings in the City Hall Commission Chambers, 100 North U.S. Hwy 1, Fort Pierce, Florida, at their meeting which begins at 6:30 p.m., to consider review and approval of the following:

1. Application for Conditional Use with New Construction submitted by property owner Hyer Management LLC, and representative William P. Stoddard to construct a single-family home seaward of the Coastal Construction Control Line (CCCL) at 324 South Ocean Drive, Fort Pierce, FL. The property is zoned Hutchinson Island Medium Density Residential Zone (R-4A), Parcel ID: 2401-501-0026-000-3.

2. Application for Conditional Use with New Construction submitted by property owner and applicant, Palmieri Design Planning LLC, to construct and establish a 59,362 square foot Assisted Living Facility with 56 units at 1600 N Lawnwood Circle, Fort Pierce, FL. 3. Application for Conditional Use with No New Construction submitted by property owner and applicant, Ann F.
