

The City Commission of the City of Fort Pierce, Florida, pursuant to Section 18-9 of the Code of Ordinances of the City of Fort Pierce, will on Monday, July 6, 2020, hold Public Hearings in the City Hall Commission Chambers, 100 North U.S. Hwy 1, Fort Pierce, Florida, at their meeting which begins at 6:30 p.m., to consider review and approval of the following:

1. Review and approval of an application for Subdivision (Replat), submitted by property owner/applicant, John B. Culverhouse, Sr. and John B. Culverhouse, Jr., & applicant/representative William P. Stoddard to subdivide 1.31 acres of land into three (3) parcels at or near 1635 Thumb Point Drive in Fort Pierce, FL. The property is zoned Single-Family Low-Density Residential Zone (R-1). Parcel ID's: 2401-605-0030-000-3 and 2401-605-0028-000-6.

2. Review and approval of an application for Subdivision (Replat), submitted by property owner/applicant, Granada Street Properties, LLC (Henry Loudon) to subdivide 1.90 acres of land into five (5) parcels at or near the southeast corner of Porpoise Avenue and Granada Street in Fort Pierce, FL.
