

The City Commission of the City of Fort Pierce, Florida, pursuant to Section 22-143 of the Code of Ordinances of the City of Fort Pierce, will on Monday, July 20, 2020 hold Public Hearings in the City Hall Commission Chambers, 100 North U.S. #1, Fort Pierce, Florida, at their meeting which begins at 6:30 p.m., to consider review and approval of the following:

1. Approval of a Conditional Use with no new construction submitted by applicant, Michelle Longarzo on behalf of Michael D. Robbins, property owner, to operate a Vacation Rental at 1014 S. 7th Street, offering lodging for less than six (6) months. The minimum rental period is identified as two (2) days. The property is zoned Single-Family Intermediate Density Zone (R-2), Parcel ID: 2415-601-0254-000-0.
2. Approval of a Conditional Use with no new construction submitted by property owner and applicant, Tiffany Wright-Ofeimu, a Vacation Rental at 715 S. Ocean Drive, Unit E, offering lodging for less than six (6) months. The minimum rental period is identified as two (2) days. 3. Approval of a Conditional Use with no new construction submitted by property owner and applicant, Tiffany Wood, a Vacation Rental at 1123 Hernando Street, Apt.
