

1. Application for Conditional Use with New Construction submitted by property owner, Nicolas Oswald and Stacey Aileen Iannotti, to construct a dune crossover located seaward of the Coastal Construction Control Line (CCCL) at 618 South Ocean Drive, Fort Pierce, FL.
