ORDINANCE NO. 20-020 - AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF FORT PIERCE, FLORIDA CHAPTER 2, ADMINISTRATION, ARTICLE IV, OFFICERS AND EMPLOYEES, DIVISION 5, POLICE OFFICERS' RETIREMENT/PENSION FUNDS, SUBDIVISION II - POLICE OFFICERS' RETIREMENT TRUST FUND; BY AMENDING SECTION 2-383, ESTABLISHMENT, PURPOSE, EFFECTIVE DATE; AMENDING SECTION 2-393, REQUIRED DISTRIBUTIONS; AMENDING SECTION 2-397(d)(1), DEFERRED RETIREMENT OPTION PLAN; PROVIDING FOR SEVERABILITY; REPEALING ALL ORDINANCES OR PARTS THEREOF IN CONFLICT; PROVIDING FOR AN EFFECTIVE DATE.
