To take precautionary measures and provide a more convenient way of responding to solicitations, the Purchasing Division has implemented an additional option for interested respondents to submit their response by email (E-Bidding). Also, the copy requirement has been modified. Interested respondents are now required to submit only one (1) original and one (1) copy.

Attached is the tabulation sheet for the above referenced bid. **One (1) of the submittals were received via E-Bid (Demandstar) and one (1) hand delivered.** A copy of each submittal received can be found in the **Interdepartmental Shared (R) Drive**, Purchasing, subject bid number, saved as "Submittal and the companies name" for your review. The file is available for review in the Purchasing Division.

The invitation was sent to 427 vendors. Twenty-One (21) vendors requested specifications with two (2) responding (9.52%) plus one "No Bid" (9.52% total response).

Recommendation to award memo should be forwarded to the Purchasing Division (copy to Director of Finance) prior to submitting an agenda item.

Expiration date is **October 22, 2021**. Commission approval must be completed by this date.
