The City Commission of the City of Fort Pierce, Florida, pursuant to Section 121-9 of the Code of Ordinances of the City of Fort Pierce, will on Monday, February 7, 2022, hold a Public Hearing in the City Hall Commission Chambers, 100 North U.S. # 1, Fort Pierce, Florida, at their meeting which begins at 6:00 p.m., to consider review and approval of an application for Final Plat, submitted by Representative, Dennis Murphy, Principle Planner of Culpepper & Terpening, Inc. and Property Owner, Isle Shores Development, LLC, to subdivide, into five (5) parcels, approximately 0.68 acres of land for the Isle Shores Development located at 1403 Desota Street, Fort Pierce, FL.
