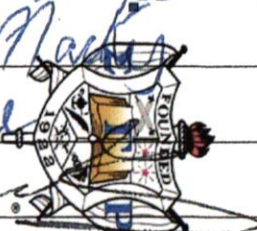
# Petition for Change of Name
