I think it would be appropriate to rename Jaycee Park after John Houghtaling. The park is located across the Indian River Lagoon from Fort Pierce City Marina, where Mr. Houghtaling lived on a houseboat during his retirement years. His boat was lost during a hurricane that heavily damaged the marina, but Mr. Houghtaling continued to live in Fort Pierce until his death in 2009. His invention was nationally recognized and familiar to travelers throughout the United States.

Please see answers above. The vibrating beds Mr. Houghtaling invented were once found in hotel rooms across the country and referenced in movies such as "National Lampoon's Family Vacation" and "Planes, Trains and Automobiles." The beds were also referenced in a Jimmy Buffett song.

Geographically, Jaycee Park makes sense. It's located along the Indian River Lagoon, which is where Mr. Houghtaling lived prior to the hurricane that destroyed his boat. According to one of his sons, he was drawn to Fort Pierce because he wanted to live on the water. It seems like a fitting tribute to a local historical figure who, as far as I know, has not been recognized elsewhere in the city.

The Sunrise Kiwanis, a civic organization in Fort Pierce, created a community rebuild of Kids Park that involved school children in design, and a broad sector of citizens for the building of an all access park for children of all capabilities.

Kiwanians are volunteers changing the world through service to children and communities. The Fort Pierce Sunrise Kiwanis Club conceived of a concept to rebuild the Kids Park at Jaycee Park, to be accessible for children of all abilities, to be durable and to be on a much larger scale than the existing park, which had fallen into disrepair. The Club approached the City of Fort Pierce, and together these organizations recruited other organizations, businesses and citizens to donate funds and volunteer for the build. Volunteers worked under the direction of Playgrounds by Leathers, a Jupiter firm that specializes in playgrounds and community builds. The project started about 18 months prior to the actual build and involved elected leaders of Fort Pierce, St. Lucie County as well as St. Lucie County schools and Fire District. Many non profits participated, including a generous contribution from the St. Lucie County Children Service Council. Public

The Fort Pierce Sunrise Kiwanis wanted not only to build a park but they wanted to build a sense of community. There were volunteer teams in charge of food, tools, volunteer recruitment, registration, and build captains who supervised volunteers. Any skill level was welcome. Park neighbors were drawn into the build, giving many volunteer hours. Local businesses donated meals for breakfast, lunch and dinner. The Fire District provided two firefighter/paramedics for the duration of the build to address any injuries. Luckily, minimal accidents occurred. Every day, local clergy would begin the day with prayer. With temperatures in the nineties, water, other drinks and ice were plentiful. A large refrigeration truck was donated for the duration of the build to keep food and drinks cold. Playgrounds by Leathers staff were on

In the early 20th century, there was no bridge over the Indian River so beachgoers in Fort Pierce went by boat from Cobb's dock or the Fort Pierce Hotel dock, to what is today known as Jaycee Park. They made a walking path to the Atlantic Ocean Beach, and called this beach Surfside.

The term Jaycee refers to an organization that was once called the Junior Chamber of Commerce. While there is an active St. Lucie County Chamber of Commerce, there is no active county Jaycee organization currently. In 1960, the City of Fort Pierce named the current Jaycee Park (Resolution 60-1991). They describe Jaycee Park as due west of Lion's Park. 1. Kiwanians are volunteers changing the world through service to children and communities. The Fort Pierce Sunrise Kiwanis Club conceived of a concept to rebuild the Kids Park at Jaycee Park, to be accessible for children of all abilities, to be durable and to be on a much larger scale than the existing park, which had fallen into disrepair. The Club approached the City of Fort Pierce, and together these organizations recruited other organizations, businesses and citizens to donate funds and volunteer for the build. Volunteers worked under the direction of Playgrounds by Leathers, a Jupiter firm that specializes in playgrounds and community builds. The project started about 18 months prior to the actual build and involved elected leaders of Fort Pierce, St. Lucie County as well as St. Lucie County schools and Fire District. Many non profits participated, including a generous contribution from the St. Lucie County Children Service Council. Public works staff from Fort Pierce worked many hours in preparing the site and during the build. The build involved over a thousand volunteers working 10 days over 120 hours to complete 99% of the build.
2. The Kids Park at Jaycee Park involved every part of the community, including volunteers from Port St. Lucie and Vero Beach. The Fort Pierce Sunrise Kiwanis wanted not only to build a park but they wanted to build a sense of community. There were volunteer teams in charge of food, tools, volunteer recruitment, registration, and build captains who supervised volunteers. Any skill level was welcome. Park neighbors were drawn into the build, giving many volunteer hours. Local businesses donated meals for breakfast, lunch and dinner. The Fire District provided two firefighter/paramedics for the duration of the build to address any injuries. Luckily, minimal accidents occurred. Every day, local clergy would begin the day with prayer. With temperatures in the nineties, water, other drinks and ice were plentiful. A large refrigeration truck was donated for the duration of the build to keep food and drinks cold. Playgrounds by Leathers staff were on site for the 10 build days. Each 12 hour day was staffed by volunteers for 4 hour shifts, for a total of 120 build hours, although organizers, build leaders and captains put in many more hours.
3. In the early 20th century, there was no bridge over the Indian River so beachgoers in Fort Pierce went by boat from Cobb's dock or the Fort Pierce Hotel dock, to what is today known as Jaycee Park. They made a walking path to the Atlantic Ocean Beach, and called this beach Surfside. The term Jaycee refers to an organization that was once called the Junior Chamber of Commerce. While there is an active St. Lucie County Chamber of Commerce, there is no active county Jaycee organization currently. In 1960, the City of Fort Pierce named the current Jaycee Park (Resolution 60-1991). They describe Jaycee Park as due west of Lion's Park. Lion's Park is today known as Surfside Park, and is probably the original Surfside Beach mentioned above. The Jaycees submitted a site plan for park improvements, including shelters, tables, storage building, toilets, play areas, and parking facilities for 263 cars and 20 cars and boat trailers. In 1982 and 1983, improvements were made and referred to as Jaycee Park Phase II. With no active involvement of local Jaycees for more than 40 years, the City of Fort Pierce has made improvements to the park, but the children's play area was out of date and in a deteriorating condition. The Fort Pierce Sunrise Kiwanis Club's spearheading of the rebuild of the kid's park, with state of the art features for children with all abilities, has been a major enhancement of the park. Features include a Coast Guard boat, a pirate ship, zig zag monkey bars, shark and conch

shell tunnels, accessible racing krooz, strap swings, and many, many more other ways for all children to have fun. It is estimated that about two million dollars was saved, because the community built the kids park. The effort of the Sunrise Kiwanis was rewarded when an organization gave a generous grant while the build was in progress. This new, enhanced, accessible-to-all-children playground would never have happened, if it had not been for the Fort Pierce Sunrise Kiwanis Club. And, because they brought the multitudes with them, the whole community has an investment in the park. Our children, grandchildren and great grandchildren will be enjoying this park long after those who participated in the build are gone.


