CONTESTING OF FINE/NON-COMPLIANCE**

1.) The gravity or seriousness of the violation:	Moderate
2a.) Any and all actions taken by the violator to correct the violations; OR	The necessary permits were obtained and the required work was completed.
2b.) If the violations were not corrected by the original violator, what action was taken by any other owner or interested party to bring the violation into compliance:	The owner hired contractors to complete the necessary repairs.
3.) The length of time necessary to bring the property into compliance:	1 year, 3 months
4.) The number of times the violator was previously found in violation by either the CEB, SM or other quasi-judicial or judicial process, or otherwise admitted guilt in any such proceeding:	2
5.) The number of violation notices the violator has received in the past, as well as their nature and final disposition of each notice:	10 total 8 were complied prior to hearing. The other 2, owner obtained permits and necessary work was completed.
6.) Whether or to what extent there are extenuating factors preventing timely compliance, such as unavoidable personal hardship:	The owner claims that the contractor created delays in completing the required work.
