

The City Commission of the City of Fort Pierce, Florida, pursuant to Section 125-37 of the Code of Ordinances of the City of Fort Pierce, will on Monday, April 17, 2023, hold a Public Hearing in the City Hall Commission Chambers, 100 North U.S. Highway 1, Fort Pierce, Florida, at their meeting which begins at 5:05 p.m., to consider review and approval of the following:

1. Application for a Conditional Use with New Construction & Design Review submitted by applicant Deborah Martohue for property owner, The Love Center Regeneration Ministries, to construct a 199-ft telecommunications tower at 3111 Avenue D, more specifically located at Parcel Control Number: 2408-123-0008-000-2.

2. Application for a Conditional Use with No New Construction & Design Review submitted by applicant iSTEAM, Inc. to operate an Elementary School at 2817 Peters Road, more specifically located at Parcel Control Number: 2324-311-0005-000-1.

3. Application for Site Plan (Development and Design Review) submitted by property owner Visconti Holdings LLC, to construct an additional 23,456 square foot expansion together with a 4,389 square foot covered awning.
