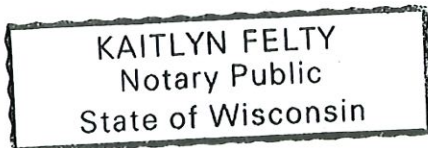

NOTICE is given that a draft of the 2023-2024 Annual Action Plan (AAP) for the City of Fort Pierce will be available for a thirty (30) day public comment and review period. Notice is also given that a Public Hearing will be held.

The City of Fort Pierce is an entitlement city and eligible for Community Development Block Grant (CDBG) funds through the U.S. Department of Housing and Urban Development. CDBG funds are utilized by the City for housing and community development activities that are intended to benefit low- to moderate-income residents in Fort Pierce. The 2021-2025 Consolidated Plan assesses the housing and community development needs and identifies the overall priority needs in the City. A strategic plan is developed, and goals are created to address identified needs. For each year of the plan an AAP is developed with activities that work to complete the goals in the Consolidated Plan. The 2021-2025 Consolidated Plan includes the third year PY 2023 AAP.

Public Comment Period: A draft of the PY 2023 AAP will be available to review from July 6, 2023, to August 5, 2023, and can be downloaded from the City's Grants Administration website at: <https://www.cityoffortpierce.com/399/Community-Development-Block-Grant-CDBG>.
