

CITY OF FORT PIERCE NOTICE OF PUBLIC HEARING

The City Commission of the City of Fort Pierce, Florida, pursuant to Sections 163.3184 and 166.041 F.S., will on Monday, April 1st, 2024, hold a public hearing for the second reading (adoption hearing) of the enactment of proposed Ordinance No. 23-057 at 5:05 p.m., in the City Hall Commission Chambers, 100 N. U.S. 1, Fort Pierce, Florida.

Ordinance 23-057 - AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF FORT PIERCE, FLORIDA; AMENDING THE FUTURE LAND USE MAP OF THE COMPREHENSIVE PLAN TO CHANGE THE DESIGNATION OF PROPERTY GENERALLY LOCATED AT THE NORTHEAST CORNER OF SELVITZ ROAD AND DEVINE ROAD AND JUST WEST OF CHRISTENSEN ROAD, FROM LOW DENSITY RESIDENTIAL, RL, TO MIXED USE DEVELOPMENT, MXD; PROVIDING FOR A SEVERABILITY CLAUSE; PROVIDING FOR REPEAL OF ORDINANCES OR PARTS THEREOF IN CONFLICT; PROVIDING FOR AN EFFECTIVE DATE.

This ordinance is being considered pursuant to application submitted by the property owner, Donald Stevenson of Selvitz I LLC, Selvitz II LLC, and Selvitz III LLC, and applicant, Daniel Sorrow, AICP, of Cofleur & Hearing, for three (3) parcels of land, 122.8 +/- acres, to change the future land use designation within the Comprehensive Plan, from RL, Low Density Residential to MXD, Mixed Use Development. Said parcels are generally located at or near the northeast corner of Selvitz Road and Devine Road and just west of Christensen Road, in Fort Pierce, Florida.

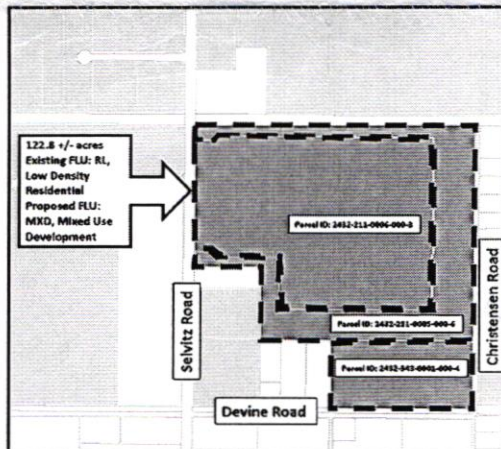
