On December 13, 2023, the Purchasing Division received specifications to go out for bid on the above subject bid. The bid was advertised on February 02 and 09, 2024, with a scheduled opening at 3:00 PM on February 29, 2024.

Respondents are now able to submit bids electronically and the hard copy requirement has been modified. Respondents that choice to submit a hard copy are required to only submit one (1) original and one(1) PDF copy on a USB Drive.

Attached is the tabulation sheet for the above referenced bid. In total, one (1) submission was hand delivered. A copy of the submittal will be sent via email. The file is available for review in the Purchasing Division.

The invitation was sent to 769 vendors. Seven (7) vendors requested specifications with one (1) responding (14.28%) plus 0 “No Bid” (14.28% total response).
