

## RESOLUTION NO. 24-R25

A RESOLUTION BY THE CITY COMMISSION OF THE CITY OF FORT PIERCE, FLORIDA **AUTHORIZING THE FORT PIERCE POLICE DEPARTMENT TO APPLY FOR PERMITS THROUGH THE FLORIDA DEPARTMENT OF TRANSPORTION FOR FLOCK AUTOMATIC LICENSE PLATE READERS**; AUTHORIZING THE CHIEF OF POLICE TO DESIGNATE A AUTHORIZED REPRESENTATIVE; AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, the Fort Pierce Police Department utilizes FLOCK Automatic License Plate Readers (LPR) within the City of Fort Pierce; and

**WHEREAS**, the Florida Department of Transportation may approve the installation of an automated license plate reader within the right-of-way of a road on the State Highway System at the request of a law enforcement agency, pursuant to section 316.0777(2)(b), Florida Statutes; and

**WHEREAS**, Rule 14-20.010 of the Florida Administrative Code dictates the requirements for General Use Permits; and

**WHEREAS**, the Florida Department of Transportation has notified the Fort Pierce Police Department a General Use Permit will be required for their FLOCK LPR; and

**WHEREAS**, the Law Enforcement Agency may designate an authorized representative to apply for a General Use Permit; and

**WHEREAS**, FLOCK Safety is qualified and willing to apply for any necessary General Use Permits required for the FLOCK LPR within the City of Fort Pierce.

**NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT PIERCE, FLORIDA THAT:**

**Section 1:** The above recitals are incorporated by reference into the body of this resolution and such recitals are adopted as findings of fact.

**Section 2:** The Fort Pierce Police Department is hereby authorized to apply for any necessary General Use Permits through the Florida Department of Transportation for operation of any FLOCK LPR within the City of Fort Pierce, pursuant to section 316.0777, Florida Statutes, and Rule 14-20.010 of the Florida Administrative Code.

**Section 3:** The Fort Pierce Police Department Chief of Police is hereby authorized to designate FLOCK Safety as an authorized representative to apply for any necessary General Use Permits in compliance with section 316.0777, Florida Statutes, and Rule 14-20.010 of the Florida Administrative Code.
