I hope this email finds you well. When you have an opportunity to discuss this grant, please let me know because I have some questions.

We finally have all the plans in for this project, which included aspects of this renovation that were not part of the grant scope of work but needed to be approved before any work can start. Those components included the fire alarm, fire suppression, and security systems.

According to the attached schedule, work will begin later this month and is not expected to be completed until September 30, 2024. Will this delay jeopardize funding?
