On May 10, 2024, the Purchasing Division received specifications to go out for bid on the above subject bid. The bid was advertised on June 3 and June 10, 2024, with a scheduled opening at 3:00 PM on June 27, 2024.

Respondents are now able to submit bids electronically and the hard copy requirement has been modified. Respondents that choice to submit a hard copy are required to only submit one (1) original and one (1) PDF copy on a USB Drive.

Attached is the tabulation sheet for the above referenced bid. In total, three (3) submissions were received electronically. A copy of the submittals will be sent via email or OneDrive. The file is available for review in the Purchasing Division.

The invitation was sent to 536 vendors. Eleven (11) vendors requested specifications with three (3) responding (27.27%) plus 0 “No Bid” (27.27% total response).

A recommendation to award form (see attached) will need to be completed and attached to the appropriate approving authority’s document (City Manager’s – Requisition or City Commission – Agenda Item).

The entire process including approval of Commission must be complete by **August 26, 2024**, which is the expiration date of the bid and responses.
