On May 15, 2024, the Purchasing Division received specifications to go out for bid on the above subject bid. The bid was advertised on June 4 and June 11, 2024, with a scheduled opening at 3:00 PM on June 20, 2024.

Respondents are now able to submit bids electronically and the hard copy requirement has been modified. Respondents that choice to submit a hard copy are required to only submit one (1) original and one (1) PDF copy on a USB Drive.

Attached is the tabulation sheet for the above referenced bid. In total, one (1) submission was received electronically. A copy of the submittals will be sent via email or OneDrive. The file is available for review in the Purchasing Division.

**The invitation was sent to 536 vendors. Fourteen (14) vendors requested specifications with one (1) responding (7.14%) plus 0 “No Bid” (7.14% total response).**

A recommendation to award form (see attached) will need to be completed and attached to the appropriate approving authority’s document (City Manager’s – Requisition or City Commission – Agenda Item).

The entire process including approval of Commission must be complete by **August 19, 2024**, which is the expiration date of the bid and responses.
