During my last assignment as Corrections / Court Services Major my division was comprised of 364 staff, including sworn law enforcement and corrections deputies as well as civilian employees. The budget for my division was 31 million dollars and we maintained care, custody and control of over 1000 inmates a day. I am certified in both Law Enforcement and Correction in the State of Florida. I also served as an educational instructor for many years during my career in varied curriculums.
