On March 22, 2024, the Purchasing Division received specifications to go out for bid on the above subject bid. The bid was advertised on April 9 and April 16, 2024, with a scheduled opening at 3:00 PM on May 7, 2024. Respondents are now able to submit bids electronically and the hard copy requirement has been modified. Respondents that choice to submit a hard copy are required to only submit one (1) original and one(1) PDF copy on a USB Drive.

Attached is the tabulation sheet for the above referenced bid. In total, two (2) submissions were received electronically. A copy of each submittal will be sent via email. The file is available for review in the Purchasing Division.

The invitation was sent to 1124 vendors. Twenty-five (25) vendors requested specifications with two (2) responding (0.08%) plus 0 “No Bid” (0.08% total response).

A recommendation to award form (see attached) will need to be completed and attached to the appropriate approving authority’s document (City Manager’s - Requisition or City Commission – Agenda Item).

Expiration date is **Tuesday, July 2, 2024**. Approval to award must be complete by this date.
