### Jon Meacham

Presidential historian and Pulitzer Prize-winning author Jon Meacham is one of America's most prominent public intellectuals. A highly sought-after commentator, Meacham regularly appears

on MSNBC, CNN, and other news outlets. A skilled orator with a depth of knowledge about politics, religion, and current affairs, Meacham has the unique ability to bring history to life and offer historical context to current events and issues impacting our daily lives – whether we realize it or not – to audiences of all backgrounds and levels of understanding.

He served as *Newsweek's* managing editor from 1998 to 2006 and as editor from 2006 to 2010.

Meacham is the author of multiple *New York Times* bestsellers. In 2022, he published *And There Was Light: Abraham Lincoln and the American Struggle*, which won numerous awards, including the Lincoln Prize, and spent 16 weeks on the *Times* bestseller list. A #1 *New York Times* bestseller, Meacham's *The Soul of America: The Battle for Our Better Angels* examines the present moment in American politics and life by looking back at critical times in U.S. history when hope overcame division and fear.

Meacham is a frequent guest on *Morning Joe*, *Real Time with Bill Maher*, *The 11th Hour*, and was featured in Ken Burns' documentary series *The Roosevelts: An Intimate History*. FOX News produced an hour-long special about Meacham's *Destiny and Power*.

Named a "Global Leader for Tomorrow" by the World Economic Forum, he is a member of the Council on Foreign Relations and a fellow of the Society of American Historians. Meacham is a distinguished visiting professor at Vanderbilt University, where he holds the Rogers Chair in the American Presidency. In 2024, he was awarded the National Humanities Medal by President Biden and was honored as a Library Lion of the New York Public Library.
