Sec. 103-373. Two-Year Terms; Nine (9) Regular Voting Members consisting of one (1) city commissioner; one (1) representative from at least six (6) of the following categories in connection with affordable housing: residential home builder, banking or mortgage industry, labor industry for home building, advocate for low-income persons, for-profit provider of affordable housing, not-for-profit provider of affordable housing, real estate professional, City Planning Board member, city resident, city employer representative, or essential services personnel representative (police, teachers, firefighters, school employees).
