On December 18, 2024, the Purchasing Division received specifications to go out for bid on the above subject bid. The bid was advertised on January 16 and January 23, 2025, with a scheduled opening at 3:00 PM on February 18, 2025.

Respondents are now able to submit bids electronically and the hard copy requirement has been modified. Respondents that choice to submit a hard copy are required to only submit one (1) original and one (1) PDF copy on a USB Drive.

Attached is the Tabulation Sheet and the Submittal Response Checklist for the above referenced bid. In total, two (2) submissions were received electronically. A copy of the submittals will be sent via email or OneDrive. The file is available for review in the Purchasing Division.

**The invitation was sent to 991 vendors. Twenty-eight (28) vendors requested specifications with two (2) responding (7.14%) plus 0 “No Bid” (7.14% total response).**

A recommendation to award form (see attached) will need to be completed and attached to the appropriate approving authority’s document (City Manager’s – Requisition or City Commission – Agenda Item).

The entire process including approval of Commission must be complete by **April 21, 2025**, which is the expiration date of the bid and responses.
