On February 10, 2025, the Purchasing Division received specifications to go out for bid on the above subject project. The bid was advertised on April 17 and April 24, 2025, with a scheduled opening at 3:00 PM on May 20, 2025.

Respondents are now able to submit bids electronically and the hard copy requirement has been modified. Respondents that choice to submit a hard copy are required to only submit one (1) original and one (1) PDF copy on a USB Drive.

Attached is the tabulation sheet and bid response checklist for the above-referenced bid. In total, three (3) submissions were received electronically, and one (1) submissions was received by delivery. A copy of the submittals will be sent via email or OneDrive. The file is available for review in the Purchasing Division.

The invitation was sent to 1009 vendors. Thirty- two (32) vendors requested specifications with four (4) responding (12.5%) plus 0 “No Bid” (12.5% total response).

A recommendation to award form (see attached) will need to be completed and attached to the appropriate approving authority’s document (City Manager’s – Requisition or City Commission – Agenda Item).

The entire process including approval of Commission must be completed by **July 20, 2025**, which is the expiration date of the bid and responses.
