DATE: December 17, 2025

On October 20, 2025, the Purchasing Division received specifications to go out for bid on the above subject project. The bid was advertised on November 7 and November 14, 2025, with a scheduled opening at 3:00 PM on December 11, 2025.

Respondents are now able to submit bids electronically and the hard copy requirement has been modified. Respondents that choice to submit a hard copy are required to only submit one (1) original and one (1) PDF copy on a USB Drive.

Attached is the tabulation sheet and bid submittals for the above-referenced bid. In total, four (4) submissions were received electronically, and one (1) submission was received by delivery. Copies of the submittals will be sent via email or OneDrive. The file is also available for review in the Purchasing Division.

The invitation was sent to 539 vendors. Thirty- five (35) vendors requested specifications with four (5) responding (14.29%) plus 0 “No Bid” (14.29% total response).

A recommendation to award form (see attached) will need to be completed and attached to the appropriate approving authority’s document (City Manager’s – Requisition or City Commission – Agenda Item).

The entire process including approval of Commission must be completed by **February 10, 2026**, which is the expiration date of the bid and responses.
