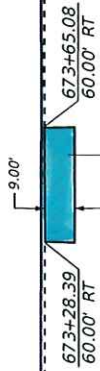
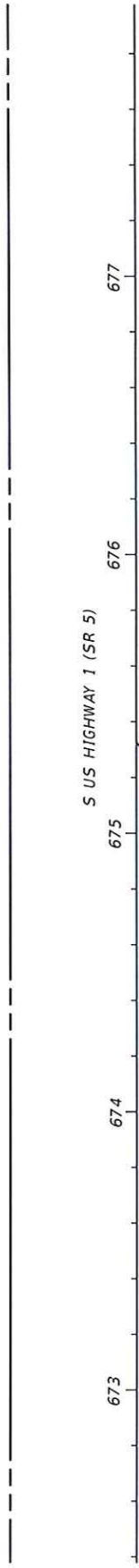

In consideration of the benefits accruing unto the licensor, the parties agree as follows:

Licensor hereby grants to Licensee a license to occupy and use, subject to all of the terms and conditions hereof, the following described premises:

A portion of a parcel of land lying in Section 22, Township 35 South, Range 40 East, St. Lucie County, Florida; said portion lying Easterly of the Existing Right of Way line of State Road 5 (S. US Highway 1), extending no more than 9.00 feet between Centerline of Construction Stations 673+28.39 and 673+65.08, as shown on the Florida Department of Transportation License Agreement Plan Sheet for Financial Project I.D. 441714-1-52-01.		

The premises may be occupied and used by licensee for restoration of the sidewalk, curb and gutter, and driveway that is beyond the Existing Right of Way line and for sloping, grading, tying in, harmonizing and reconnecting existing features, together with the right of access, ingress and egress of the licensor's property with the highway improvements which are to be constructed together with incidental purposes related thereto during the period beginning with the date first above written and continuing until completion of the transportation project, but not later than the last day of July 29, 2031.
