

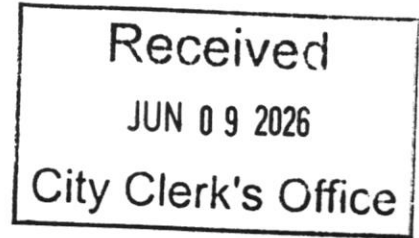

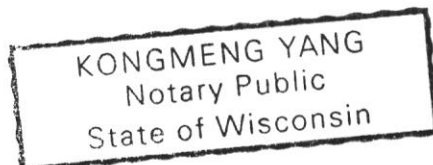

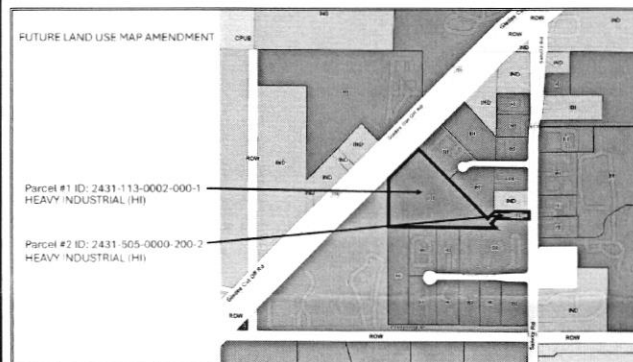


CITY OF FORT PIERCE NOTICE OF PUBLIC HEARING

The City Commission of the City of Fort Pierce, Florida, pursuant to Section 125-37 of the Code of Ordinances of the City of Fort Pierce, and Sections 166.041 (3)(a) and 163.3187 of Florida State Statutes, will on Monday, June 15, 2026 and Monday, July 6, 2026 hold Public Hearings on the enactment of the proposed ordinance on first and second readings, respectively, in the City Hall Commission Chambers, 100 North U.S. #1, Fort Pierce, Florida, at their meetings which begin at 5:05 p.m., to consider review and approval of the following:

ORDINANCE 26-012: AN ORDINANCE EXTENDING THE TERRITORIAL LIMITS OF THE CITY OF FORT PIERCE, FLORIDA, AMENDING THE FUTURE LAND USE MAP OF THE COMPREHENSIVE PLAN TO CHANGE THE FUTURE LAND USE DESIGNATION OF TWO (2) PARCELS CONTAINING APPROXIMATELY 10.53 ACRES GENERALLY LOCATED AT OR NEAR SELVITZ ROAD AND GLADES CUT-OFF ROAD, SHOWN ON EXHIBIT A, FROM ST LUCIE COUNTY FUTURE LAND USE DESIGNATION OF INDUSTRIAL (IND) TO CITY OF FORT PIERCE FUTURE LAND USE DESIGNATION OF HEAVY INDUSTRIAL (HI); PROVIDING FOR A SEVERABILITY CLAUSE; REPEALING ALL ORDINANCES OR PARTS THEREOF IN CONFLICT HEREWITH; AND PROVIDING FOR AN EFFECTIVE DATE
